#### **Welcome and Comments:**

Whittington W. Clement, Secretary of Transportation and Chairman of the Commonwealth Transportation Board, extended a welcome to the Board members, Department staff, and honored guests including Senator John H. Chichester, chairman of the Senate Finance Committee, and Senator Charles R. Hawkins, chairman of the Transportation Subcommittee of Senate Finance. Chairman Clement welcomed and introduced the Honorable Mark R. Warner, Governor of Virginia.

Mr. Warner addressed the Board and urged the restructuring of the Department's six-year plan and financial programs to regain credibility and restore public confidence. A draft text of his comments is attached.

Chairman Clement welcomed and introduced the Honorable Ray D. Pethtel, Interim Commissioner for the Department.

Mr. Pethtel distributed and presented an overview of the Department's current financial status with program impacts. He pledged to provide the General Assembly within thirty days a detailed financial and program restructuring proposal. A copy of his presentation is attached.

Chairman Clement welcomed and introduced Pierce R. Homer, new Deputy Secretary of Transportation.
