




Project Overview MeadWestvaco Corporation

- **Company description:** MeadWestvaco manufactures paper products
- Project description:
 - 4,400 feet of track, with three in-plant switches to serve the expanded facility
 - Improves a freight rail shipping connection in the I-81 corridor
- □ Supports \$33 million in local investment and creates 60 jobs
- Supports more than 500 railcar shipments per year and scored "Fair" at 63 out of 100 points
- Project has the support of the Virginia Economic Development Partnership and Augusta County
- Allocation would require the CTB to waive the Section II-E Allocation of Funds limit of \$450,000 per jurisdiction per year
- **Recommended funding:** \$450,000 state, \$150,000 matching funds






Project Overview Hershey Chocolate Company of Virginia

- Company description: Hershey Chocolate Co. of Virginia processes, finishes and packages Hershey brand products
- Project description:
 - 5 new rail spurs (3,000 feet of track) to expand the existing rail yard
 - Improves a freight rail shipping connection in the I-81 corridor
- Supports \$6.4 million in local capital investment and creates 70 jobs
- Supports more than 1,000 railcar shipments per year and scored "Good" at 66 out of 100 points
- Project has the support of the Virginia Economic Development Partnership and Augusta County
- Allocation would require the CTB to waive the Section II-E Allocation of Funds limit of \$450,000 per jurisdiction per year
- **Recommended funding:** \$450,000 state, \$150,000 matching funds




Project Overview Gerald M. Moore & Son

- Company description: A full service site preparation and paving contractor
 Preject description:
- Project description:
 - Construction of a siding (1,800 feet of track)
 - Increases freight rail shipping capacity along Route 13 to the Eastern Shore
- Supports local capital investment of \$250,000, recent capital improvements totaled \$1 million. Creates 20 jobs.
- Supports 500 railcar shipments per year and scored "Fair" at 62 out of 100 points.
- Project has the support of the Accomack-Northampton Transportation District Commission
- Allocation would require the CTB to acknowledge that the total capital investment associated with this project has been achieved over time since 2005
- **Recommended funding:** \$131,800 state, unmatched



LiteSteel Technologies America, LLC Troutville, Botetourt Co.





Project Overview LiteSteel Technologies America, LLC

- Company description: LiteSteel manufactures steel products for use in residential and commercial buildings
- Project description:
 - Construction of 1,851 feet of track to serve the facility
 - Creates a new freight rail shipping connection in the I-81 corridor
- Supports \$24 million in local capital investment and creates 55 jobs
- Supports more than 500 railcar shipments per year and scored "Good" at 68 out of 100 points
- Project has the support of the Virginia Economic Development Partnership and the Botetourt County Board of Supervisors
- Project is part of the Governor's economic development initiative
- Project would require the CTB to fund construction costs incurred prior to agreement
- **Recommended funding:** \$433,329 state, \$133,329 matching funds
