<u>Title: Revenue Sharing Reallocation</u> <u>Buchanan County</u>

WHEREAS, Section 33.1-23.05 of the *Code of Virginia* prescribes the annual allocation of state funds to provide an equivalent matching allocation for certain local funds designated by the governing body to be placed in a special fund account; and,

WHEREAS, the governing body of Buchanan County elected to participate in this program for Fiscal Years 2006 thru 2009, and, with the Virginia Department of Transportation (VDOT), identified specific eligible items of work to be financed from the special fund account; and,

WHEREAS, the governing body of Buchanan County has, by appropriate resolution, requested routes 83, 651, 609, and 616 to be established as revenue sharing projects,

WHEREAS the governing body of Buchanan County has, by appropriate resolution, requested these funds to be reallocated to Routes 83, 651, 609 and 616 for specific eligible items of work, as indicated herein; and,

WHEREAS, these items of work fall within the intent of Section 33.1-23.05 of the *Code of Virginia*, and comply with VDOT's guidelines for the use of such funds.
