<u>Title: Revenue Sharing Reallocation</u> <u>Augusta County</u>

**WHEREAS,** Section 33.1-23.05 of the *Code of Virginia* prescribes the annual allocation of state funds to provide an equivalent matching allocation for certain local funds designated by the governing body to be placed in a special fund account; and,

WHEREAS, the governing body of Augusta County elected to participate in this program for Fiscal Years 1998-99 thru 2005-06 and, with the Virginia Department of Transportation (VDOT), identified specific eligible items of work to be financed from the special fund account; and,

**WHEREAS,** the governing body of Augusta County has, by appropriate resolution, requested Routes 688, 845, 862, 832, and 833 to be established as a revenue sharing projects,

**WHEREAS,** the governing body of Augusta County has, by appropriate resolution, requested the Fiscal Years 1998-99 thru 2005-06 funds to be reallocated to Routes 688, 845, 862, 832, and 833 for specific eligible items of work, as indicated herein; and,

**WHEREAS,** these items of work fall within the intent of Section 33.1-23.05 of the *Code of Virginia*, and comply with VDOT's guidelines for the use of such funds.

**NOW, THEREFORE, BE IT RESOLVED,** that the Commonwealth Transportation Board hereby approves the reallocation of these funds as set forth and indicated herein.
