<u>Title: Revenue Sharing Reallocation</u> <u>City of Danville</u>

WHEREAS, Section 33.1-23.05 of the *Code of Virginia* prescribes the annual allocation of state funds to provide an equivalent matching allocation for certain local funds designated by the governing body to be placed in a special fund account; and,

WHEREAS, the governing body of the City of Danville elected to participate in this program for Fiscal Year 2012, and, with the Virginia Department of Transportation (VDOT), identified specific eligible items of work to be financed from the special fund account; and,

WHEREAS, the governing body of the City of Danville has, by appropriate resolution, requested Main St./Union St. – River District Improvement (UPC 102441) to be established as a revenue sharing project,

WHEREAS the governing body of the City of Danville has, by appropriate resolution requested that the funds set forth herein be transferred to Main St./Union St. – River District Improvement (UPC 102441) for specific eligible items of work, as indicated herein; and,

WHEREAS, these items of work fall within the intent of Section 33.1-23.05 of the *Code of Virginia*, and comply with VDOT's guidelines for the use of such funds.
