<u>Title: Revenue Sharing Reallocation</u> **Botetourt County**

WHEREAS, Section 33.1-23.05 of the *Code of Virginia* prescribes the annual allocation of state funds to provide an equivalent matching allocation for certain local funds designated by the governing body to be placed in a special fund account; and,

WHEREAS, the governing body of Botetourt County elected to participate in this program for Fiscal Years 2002 thru 2006, and with the Virginia Department of Transportation (VDOT), identified specific eligible items of work to be financed from the special fund account; and,

WHEREAS, the governing body of Botetourt County has, by appropriate resolution, requested Routes 1303, 0800 and 0666 to be established as revenue sharing projects; and,

WHEREAS the governing body of Botetourt County has, by appropriate resolution requested that the funds set forth herein be reallocated to Routes 1303, 0800, and 0666 for specific eligible items of work, as indicated herein; and,

WHEREAS, these items of work fall within the intent of Section 33.1-23.05 of the *Code of Virginia*, and comply with VDOT's guidelines for the use of such funds.

NOW, THEREFORE, BE IT RESOLVED, that the Commonwealth Transportation Board hereby approves the reallocation of these funds as set forth and indicated herein.
