Route 460 Corridor PPTA

- Based on the previous presentation on the major terms for the Route 460 Corridor Improvements Project, amendments and transfers are necessary to the FY2013-2018 SYIP, which is the standard business practice and process.
- New UPCs need to be set up to properly manage the project components and the SYIP will need to be amended.
- Funds must be transferred to the appropriate UPCs for the funding of construction, project oversight and debt service.
- Request CTB approval of these actions today.

Current UPCs in SYIP to Retain

- UPC 56638 Preliminary Engineering /Location and Environmental Study
 - Cost for environmental studies for the Route 460 PPTA project
 - Parent UPC to 84272 and 100432

- ✓ UPC 84272 Project Management: Costs associated with the PPTA procurement and project development activities
- ✓ UPC 100432 Project Oversight: Cost associated with VDOT's oversight after the project goes to close

Amendments to the FY 2013-2018 SYIP

- UPC 103803 Route 460 PPTA Construction
 - Captures both the private and public contributions for the project
 - \checkmark Captures the private contributions from the Funding Corporation
 - Captures public contributions of GARVEEs, CPR Bonds, VPA funds, PTF
- UPC 103754 GARVEE Debt Service

 Captures the federal funds paying the principal and interest for the GARVEE bonds allocated to the Route 460 project

Transfers for FY 2013-2018 SYIP

- Transfer \$150.0M of CPR Bonds and \$22.1M PTF from UPC 81327 (PPTA Initiatives) to UPC 103803 (Route 460 PPTA Construction)
- Transfer \$330.9M of GARVEE bonds from UPC T10560 (GARVEE Bonds Balance Entry) to UPC 103803 (Route 460 PPTA Construction)
- Transfer \$250.0M of VPA funds from UPC 84272 (PPTA Project Management) to UPC 103803 (Route 460 PPTA Construction)
- Transfer \$300.0M of GARVEE bonds from UPC 102710 (I-95 HOV/HOT Public Contribution) to UPC 103803 (Route 460 PPTA Construction)
 - Request approval of this transfer to be contingent upon receipt of TIFIA for I-95, which is expected in late October

Transfers for FY 2013-2018 SYIP

- Show \$216.0M from the Funding Corporation on UPC 103803 (Route 460 PPTA Construction)
 - Allocations are not included in VDOT budget; no action needed.

- Transfer \$167.1M of federal funds for debt service from UPC T10588 (Debt Service Balance Entry) to UPC 103754 (Route 460 PPTA Debt Service)
- Transfer \$222,853 in federal funds from the UPC 81327 PPTA Initiatives to UPC 100432 (Project Oversight Route 460 PPTA Corridor Improvement Project)
- During FY 2014-2019 SYIP update, \$161.9M of additional GARVEEs will be programmed in FY 2017
 - \$127.0M on UPC 103803 (Route 460 PPTA Construction)
 - \$34.9M on UPC 100432 (Project Oversight Route 460 Corridor Improvement Project)
