Route 29 Solutions Strategy

Charge from Secretary Layne:

- I. Serve as a facilitator to find a reasonable, cost-effective solution to improve mobility in the Rt. 29 Charlottesville corridor.
- 2. Solution must be built or substantially underway in 4 years.
- 3. Doing nothing is not an option.
- 4. Work with a 10-member Advisory Panel, VDOT and DRPT.
- 5. Be transparent.
- 6. Work within budget of funds already dedicated to Rt. 29 corridor in Charlottesville: approximately \$200 million
- 7. Bring recommendation to CTB no later than May 14.



Plan of Action

- Assemble the Advisory Panel
- Convene 3 Advisory Panel meetings
- Engage technical expertise for evaluation and analysis

Purpose

 Solicit and use Advisory Panel input to develop a technically sound alternative that meets the primary objective of the Secretary's charge.
