**Title: Revenue Sharing Reallocation
Town of Dumfries**

WHEREAS, Section 33.1-23.05 of the *Code of Virginia* (1950), as amended (“*Code*”) prescribes that from funds made available by the General Assembly, the Commonwealth Transportation Board (CTB) may make an equivalent matching allocation to any locality for the improvement, construction, reconstruction or maintenance of the highway systems within such locality; and

WHEREAS, the governing body of the Town of Dumfries elected to participate in this program for Fiscal Years 2012 and 2013, and, with the Virginia Department of Transportation (VDOT), identified specific eligible items of work to be financed from the special fund account; and

WHEREAS, the governing body of the Town of Dumfries has, by appropriate resolution, requested Route 1 – Improvements to Main Street project (UPC 81517) and Possum Point Road Drainage Improvements project (UPC 104056), to be established as revenue sharing projects; and

WHEREAS, the governing body of the Town of Dumfries has, by appropriate resolution, requested that the funds set forth herein be transferred to the Main Street project (UPC 81517) and to the Possum Point Road project (UPC 104056) for specific eligible items of work, as indicated herein; and
