# Title: <u>Revenue Sharing Reallocation</u> <u>Isle of Wight County – Morgart's Beach Road</u>

**WHEREAS**, Section 33.2-357 of the *Code of Virginia* (1950), as amended ("*Code*") prescribes that from funds made available by the General Assembly, the Commonwealth Transportation Board (CTB) may make an equivalent matching allocation to any locality for the improvement, construction, reconstruction or maintenance of the highway systems within such locality; and

**WHEREAS,** the governing body of the County of Isle of Wight elected to participate in this program for Fiscal Years 2004, 2006, and 2008, and, with the Virginia Department of Transportation (VDOT), identified specific eligible items of work to be financed from the special fund account; and

**WHEREAS,** the governing body of the County of Isle of Wight has, by appropriate resolution, requested the Morgart's Beach Road (UPC 104806) project to be established as a revenue sharing project; and

**WHEREAS,** the governing body of the County of Isle of Wight has, by appropriate resolution, requested that the funds set forth herein be transferred to the Morgart's Beach Road project (UPC 104806) for specific eligible items of work, as indicated herein; and

**WHEREAS**, these items of work fall within the intent of § 33.2-357 of the *Code*, and comply with the CTB's guidelines for the use of such funds.
