### Title: <u>Revenue Sharing Reallocation</u> <u>Town of Abingdon – Green Spring Road Realignment</u>

**WHEREAS**, Section 33.2-357 of the *Code of Virginia* (1950), as amended ("*Code*") prescribes that from funds made available by the General Assembly, the Commonwealth Transportation Board (CTB) may make an equivalent matching allocation to any locality for the improvement, construction, reconstruction or maintenance of the highway systems within such locality; and

**WHEREAS,** the governing body of the Town of Abingdon elected to participate in this program for Fiscal Year 2014, and, with the Virginia Department of Transportation (VDOT), identified specific eligible items of work to be financed from the special fund account; and

**WHEREAS,** the governing body of the Town of Abingdon has, by appropriate resolution, requested the Green Spring Road Realignment (UPC 107752) project to be established as a revenue sharing project; and

**WHEREAS,** the governing body of the Town of Abingdon has, <u>by appropriate</u> <u>resolution</u>, requested that the funds set forth herein be transferred to the Green Spring Road Realignment project (UPC 107752) for specific eligible items of work, as indicated herein; and

**WHEREAS**, these items of work fall within the intent of § 33.2-357 of the *Code*, and comply with the CTB's guidelines for the use of such funds.
