# Title: <u>Revenue Sharing Reallocation</u> <u>City of Lynchburg – Downtown Streetscape Reconstruction and Improvements</u>

**WHEREAS**, Section 33.2-357 of the *Code of Virginia* (1950), as amended ("*Code*") prescribes that from funds made available by the General Assembly, the Commonwealth Transportation Board (CTB) may make an equivalent matching allocation to any locality for the improvement, construction, reconstruction or maintenance of the highway systems within such locality; and

**WHEREAS,** the governing body of the City of Lynchburg elected to participate in this program for Fiscal Years 2011 and 2014, and, with the Virginia Department of Transportation (VDOT), identified specific eligible items of work to be financed from the special fund account; and

**WHEREAS,** the governing body of the City of Lynchburg has, by appropriate resolution, requested the Downtown Streetscape Reconstruction and Improvements project (UPC 107756) to be established as a revenue sharing project; and

WHEREAS, the governing body of the City of Lynchburg has, by appropriate resolution, requested that the funds set forth herein be transferred to the Downtown Streetscape Reconstruction and Improvements project (UPC 107756) for specific eligible items of work, as indicated herein; and

**WHEREAS**, these items of work fall within the intent of § 33.2-357 of the *Code*, and comply with the CTB's guidelines for the use of such funds.
