RESOLUTION OF THE COMMONWEALTH TRANSPORTATION BOARD

<u>Title: Allocation of Funding from the Priority Transportation Fund to the I-395 Northern</u> <u>Extension Express Lanes Study (UPC 108313)</u>

WHEREAS, the Comprehensive Agreement executed in 2012 with 95 Express Lanes, LLC (95 Express Lanes) for the I-95 Express Lanes contemplated the potential future development of High Occupancy Toll Lanes along the I-395 corridor (I-395 Express Lanes Project); and

WHEREAS, in November of 2015, the Virginia Department of Transportation (VDOT) and 95 Express Lanes signed a Development Framework Agreement (Agreement) outlining the Parties' initial roles and responsibilities relating to development of the I-395 Express Lanes Project; and

WHEREAS, the Parties agree that the purpose of this Agreement is to advance the I-395 Express Lanes Project as a Concessionaire Project Enhancement under the structure of Section 12.06(a) of the Comprehensive Agreement; and

WHEREAS, improvements are to be built within VDOT's existing right of way; and

WHEREAS, the Parties will work together to finalize the scope, finance plan and agreement for the I-395 Express Lanes Project; and

WHEREAS, VDOT is initiating preparation of an Environmental Assessment (EA) for the I-395 Express Lanes Project; and

WHEREAS, the Department of Rail and Public Transportation is leading a Transit/Transportation Demand Management (TDM) Study to identify transit services and TDM program enhancements that would increase mobility and benefit toll payers in the I-95/I-395 corridor; and

WHEREAS, the costs to complete the EA, to fully develop the contractual terms of this project, and to complete the Transit/TDM Study (collectively, the I-395 Northern Extension Express Lanes Study) are expected to be \$5,000,000; and

WHEREAS, in accordance with § 33.2-1527, current funding is available in the Priority Transportation Fund (PTF) after providing for the debt service payments supported by the PTF to provide the needed funding for the I-395 Northern Extension Express Lanes Study.

NOW, THEREFORE, BE IT RESOLVED, that the Commonwealth Transportation Board, hereby approves and authorizes an allocation of \$5,000,000 from the Priority Transportation Fund to be used to support the I-395 Northern Extension Express Lanes Study (UPC 108313).
