RESOLUTION OF THE COMMONWEALTH TRANSPORTATION BOARD

July 18, 2018

<u>Title: Approval of Proposed Limited Access Control Change (LACC)</u> <u>Route 639 (Ladysmith Road) Reconstruction and Widening</u> <u>Caroline County</u>

WHEREAS, on October 4, 1956, the State Highway Commission, predecessor to the Commonwealth Transportation Board (CTB), designated the Interstate Highway System, including I-95, to be Limited Access Highways in accordance with then Article 3, Chapter 1, Title 33 of the Code of Virginia of 1950, as amended, and established the limited access line locations and limits as "the final locations of said routes, including all necessary grade separations, interchanges, ramps, etc."; and

WHEREAS, the purpose of the Project is to widen Route 639 (Ladysmith Road) from 2 to 4 lanes, install median, curb and gutter, sidewalks and bicycle accommodations and tie–in to a bridge over I-95. Additional through and turn lanes will be provided at the Route 1/639 intersection and the project will require modification to the Limited Access Control Line along I-95 adjacent to the SBL Exit Ramp, as proposed and noted in the attachment; and

WHEREAS, in accordance with §33.2-208.B of the *Code of Virginia* (1950), as amended, and policies of the Commonwealth Transportation Board, a Design Public Hearing was held at the Lewis and Clark Elementary School, 18101 Clark and York Boulevard, Ruther Glen, VA 22546-2896 on Wednesday, April 18, 2018, between 5:00 pm and 7:00 pm for the purpose of considering the proposed design of State Project 0639-016-623, P10, including the proposed changes to the limited access control limits (the "Project"); and

WHEREAS, proper notice of the Design Public Hearing was given in advance, and all those present were given a full opportunity to express their opinions and recommendations for or against the proposed Project as presented, their statements being duly recorded; and

WHEREAS, the economic, social and environmental effects of the proposed Project have been duly examined and given proper consideration and this evidence, along with all other, has been carefully reviewed; and

WHEREAS, the Fredericksburg District has reviewed and approved the traffic analysis report dated April 17, 2015 and found that it adequately addresses the impacts from the Project and the proposed change to the limited access controls; and

WHEREAS, the proposed Project is in compliance with National Environmental Policy Act (NEPA) requirements. A Categorical Exclusion (CE) between VDOT and the Federal Highway Administration dated April 12, 2018 has been approved by the FHWA; and

WHEREAS, the Project is in an attainment area and will not have an adverse impact on air quality; and

WHEREAS, FHWA provided the requisite approval for State Highway Project 0639-016-623, P101, UPC 106670 and the proposed LACCs on June 5, 2018; and

WHEREAS, the Chief Engineer has determined that the proposed change will not adversely affect the safety or operation of the highways; and

WHEREAS, in addition to the Design Public Hearing, a Notice of Willingness for Public Comment regarding the LACC was posted with the comment period closing May 19, 2018 and no requests for a hearing or other comments were received; and

WHEREAS, the proposed Project is in the County of Caroline and is supported by a letter from the County Administrator dated May 16, 2018; and

WHEREAS, the Department has reviewed the requested change and determined that all requirements of 24 VAC 30-401-20 have been met; and

WHEREAS, VDOT recommends approval of the LACC as proposed and seeks authorization for the Commissioner to take all actions necessary to implement that decision.

NOW, THEREFORE, BE IT RESOLVED, in accordance with section 33.2-401 of the *Code of Virginia* (1950), as amended, and 24 VAC 30-401-20, the CTB hereby finds and concurs

with the determinations and recommendations made by VDOT and approves the limited access change recommended by VDOT.

BE IT FURTHER RESOLVED, that the Commissioner of Highways is hereby authorized to take all actions and execute any and all documents needed to comply with this resolution.

CTB Decision Brief <u>Proposed Limited Access Control Changes</u> <u>Route 639 (Ladysmith Road) Reconstruction and Widening</u> <u>Project 0639-016-623, P101; UPC 106670</u> <u>Caroline County</u>

Issues: The purpose of the proposed project, State Highway Project 0639-016-623, P101; UPC 106670 ("Route 639 Ladysmith Road Reconstruction and Widening" or "Project") is to widen Route 639 (Ladysmith Road) from 2 to 4 lanes, install median, curb and gutter, sidewalks and bike accommodations and tie–in to a bridge over I-95. The project will require modification to the Limited Access Control Line along I-95 adjacent to the SBL Exit Ramp, (Limited Access Control Change or LACC) in the County of Caroline, as proposed and noted in the attachment. Pursuant to §33.2-401 of the *Code of Virginia*, the Commonwealth Transportation Board (CTB) must approve this LACC.

Facts:

- Limited Access Control for Interstate 95 at the Interchange was previously established by the State Highway Commission, predecessor to the CTB, October 4, 1956, at the final locations of said routes, including all necessary grade separations, interchanges, ramps, etc.
- In accordance with §33.2-208.B of the Code of Virginia (1950), as amended, and policies of the Commonwealth Transportation Board, a Design Public Hearing was held on Wednesday, April 18, 2018, between 5:00 pm and 7:00 pm at the Lewis and Clark Elementary School, 18101 Clark and York Boulevard, Ruther Glen, VA 22546-2896 to consider the Project, including the proposed changes to the limited access control limits.
- Proper notice was given in advance, and all those present were given a full opportunity to express their opinions and recommendations for or against the proposed Project as presented, their statements being duly recorded in emails and comment sheets.
- The economic, social, and environmental effects of the proposed Project have been duly examined and given proper consideration, and this evidence, along with all other has been carefully reviewed.
- The Fredericksburg District has reviewed and approved the traffic analysis report dated April 17, 2015 and found that it adequately addresses the impacts from the Project and the proposed change to the limited access controls.
- The proposed Project is in compliance with National Environmental Policy Act (NEPA) requirements. A Categorical Exclusion (CE) between VDOT and the Federal Highway Administration dated April 12, 2018 has been approved by FHWA.
- The Project is in an attainment area and will not have an adverse impact on air quality.
- The FHWA provided the approval for State Highway Project 0639-016-623, P101, UPC 106670 and the proposed LACCs on June 5, 2018.
- The Chief Engineer has determined that the proposed change will not adversely affect the safety or operation of the highways.
- The proposed project is in the County of Caroline and is supported by a letter from the County Administrator dated May 16, 2018.

- In addition to the Design Public Hearing, a Notice of Willingness for Public Comment regarding the LACC was posted with the comment period closing May 19, 2018 and no requests for a hearing or other comments were received.
- The proposed LACC is in compliance with the policies and requirements of the CTB contained in Title 24, Agency 30, Chapter 401 of the *Virginia Administrative Code*.

Recommendations: It is recommended that, pursuant to §33.2-401 of the *Code of Virginia*, and Title 24, Agency 30, Chapter 401 of the Virginia Administrative Code, the I-95 corridor in Caroline continue to be designated as a Limited Access Highway with the limited access control being modified and/or established as shown on the attached exhibits. This action will modify the limited access line and right of way previously approved by the CTB's predecessor, the State Highway Commission, on October 4, 1956.

Action Required by CTB: Virginia Code § 33.2-401 requires a majority vote of the CTB to approve the recommended LACC. The CTB will be presented with a resolution for a formal vote to approve the limited access control change for the proposed project and to provide the Commissioner of Highways the requisite authority to execute all documents necessary to implement the LACC.

Result, if Approved: The Commissioner of Highways will be authorized to execute any and all documents needed to comply with the resolution, and the Route 639 Reconstruction and Widening Project will move forward.

Options: Approve, Deny, or Defer.

Public Comments/Reactions: There were one hundred twenty nine (129) citizens that attended the meeting per the sign in sheets. Eighty seven (87) attendees filled out a comment sheet. In addition eighty nine (89) comments were received by email and US Mail during the comment period.

Eighteen (18) were in favor of the proposed improvements.

- Eight (8) respondents were in favor of the proposed improvements as presented.
- Ten (10 were in favor but wanted an alternate entrance

One hundred fifty eight (158) respondents were not in favor of the project.

- Fifty two (52) comments were asking for an alternative entrance through Prosperity Way
- Eighty one (81) comments were opposed to having to make a u-turn
- Three (3) comments wanted an alternative design for the bike and pedestrian accommodations.
- Eighteen (18) comments thought the 28' median was too large and an unnecessary use of right of way.

- Three (3) comments on Rte. 639 EB traffic accessing the McDonalds and the ability of vehicles making a left turn off of Green Road.
- One (1) comment on the median preventing left hand turns into Food Lion Shopping Center.

Moved by Mr. Flyths, seconded by Sanator Melson, that, Mhereas, under suthority of Section 33-115.2 of the 1950 Gods of Virginis, as anomaled, request is made by City of Warwick for payment at the base rate of 500 per Mile annually on additional streets meeting the required standards; Now, Therefore, be it resolved, that quarterly payments at the base rate of \$500 Per Mile annually be made to the City of Warwick on additional streets totaling 11.20 miles, effective beginning the second quarter, October 1, 1956. Notion carried.

Noved by Mr. Flythis, seconded by Senator Nelson, that, Whereas, under authority of Section 53-115.2 of the 1950 Code of Virginia, as anemaled, request is made by City of Vaynesboro for payment at the base rate of 9500 per Mile annually on additional streets meeting the required standards; Now, Therefore, be it resolved, that quarterly payments at the base rate of \$500 Per Mile annually be made to the City of Waynesboro on additional streets totaling 10.512 miles, effective beginning the second guarter, October 1, 1956. Notion carried.

Noved by Mr. Flythe, seconded by Senator Nelson, that, Whereas, under authority of Section 55-115.2 of the 1950 Code of Virginia, as snended, request is made by the Town of Wytheville for payment at the base rate of \$500 Per Mile annually on additional streats meeting the required standards; Now, Therefore, be it resolved, that quarterly payments at the base rate of \$500 Per Mile annually be made to the Town of Wytheville on additional streats totaling 0.984 Mile, affective beginning the second quarter, October 1, 1956. Motion carried.

Moved by Mr. Flythe, seconded by Senator Helson, that, it so be declared that, Whereas, by action of the Congress of the United States, whereby all routes on the Mational System of Interstate and Defense Highways are to be constructed to interstate standards and whereas, one of the requirements of interstate standards is the control of access to these routes; Therefore, he it resolved that all routes on the Mational System of Interstate and Defense Highways within the confines of the Commonwealth of Virginia, upon determining the final location of acid routes, including all necessary grade separations, interchanges, ramps, etc., are here and now designated Limited Access Highways, pursuant to Article 8, Chapter 1, Title 33, of the Code of Virginia of 1950, as amended.

On notion made by Senator Melson, seconded by Mr. Barrow, the Chairman was instructed to report to the Eurean of Public Roads, at a meeting called for Ootober 9, that the Virginia Department of Highways will undertake one-third of the cost of operation and maintenance of the proposed bridge over the Potemac River at Jones Point, with the thought that the other two-thirds shall be borne by the State of Maryland and the District of Columbia. Dear Ms. Yung,

As you are aware, The Virginia Department of Transportation is developing plans for the reconstruction and widening of Route 639 (Ladysmith Road) between U. S. Route 1 and Interstate I-95 in Caroline County. Interstate I-95 was designated a Limited Access Highway by the State Highway Commission, predecessor to the Commonwealth Transportation Board (CTB), on October 4, 1956.

The current design of the project was developed to tie into the existing location of the bridge over I-95. The Final Categorical Exclusion NEPA document for this project was completed on April 12. 2018. The Public Hearing for this project was held Wednesday April 18, 2018 and the project is being prepared for design approval by the Deputy Chief Engineer.

As a result of the design of the project, the Limited Access Line at the western side of the southbound off ramp from I-95 needs to be modified from the existing condition. This modification will actually extend the Limited Access Line in a westerly direction, approximately 67 feet beyond the current limits, to the McDonald's entrance, while vacating a portion of the existing Limited Access Line. While the length of the Limited Access Line does not extend the

full, recommended, length of 300' from the ramp terminal, it is an improvement over existing conditions. Discussions with the FHWA Area Engineer, Elliott Moore, have concluded that a Design Exception for this condition is not necessary, as the ramp terminal is an existing condition that is exempt per the Access Control for Interstate Interchanges Agreement between FHWA and VDOT.

Attached please find a copy of the Vicinity Map, Title Sheet, Plan Sheet, exhibit showing the changes to the Limited Access Line and a letter of support from Caroline County.

VDOT approves of the Limited Access Control Change as shown on the exhibit. We are requesting a quick review and approval of this limited access change no later than June 23, 2018 so that the Commonwealth Transportation Board can approve the changes at their July meeting on July 18, 2018.


