# RESOLUTION <br> OF THE <br> COMMONWEALTH TRANSPORTATION BOARD

## MOTION

Title: Highway Naming: "Ozbat Circle"
WHEREAS, Prince George County wishes to honor and memorialize Captain Jesse A. Ozbat, for his service and ultimate sacrifice as a member of the United States Army. Captain Ozbat, while assigned to $168^{\text {th }}$ Brigade Support Battalion, $214^{\text {th }}$ Fires Brigade, Fort Sill, Oklahoma died on May 20, 2012 from wounds suffered during an enemy attack of his unit in Tarin Kowt, Afghanistan.

WHEREAS, in accordance with § 33.2-213 of the Code of Virginia, Prince George County has requested, by resolution dated March 27, 2018, that the Commonwealth Transportation Board (CTB), to honor and memorialize the life and ultimate sacrifice of Captain Jesse A. Ozbat, name the roundabout at the intersection of Route 634, Allin Road, and Route 630, Jefferson Park Road and Bull Hill Road, Prince George County as "Ozbat Circle"; and

WHEREAS, § 33.2-213 provides that the Virginia Department of Transportation (VDOT) shall place and maintain appropriate signs indicating the names of highways, bridges, interchanges, and other transportation facilities named by the CTB and requires that the costs of producing, placing, and maintaining such signs shall be paid by the localities in which they are located or by the private entity whose name is attached to the transportation facility so named; and

WHEREAS, Prince George County has agreed to pay VDOT for the costs of producing, placing, and maintaining the signs calling attention to this naming.

NOW THEREFORE BE IT RESOLVED, pursuant to § 33.2-213 of the Code of
Virginia, the CTB hereby names the roundabout at the intersection of Route 634, Allin Road, and Route 630, Jefferson Park Road and Bull Hill Road, Prince George County as the "Ozbat Circle"; and

BE IT FURTHER RESOLVED, that VDOT is directed to produce, place, and maintain the signs calling attention to this naming, and secure payment from Prince George County for these costs as required by law.

CTB Decision Brief<br>Highway Naming: "Ozbat Circle"

Issue: Approval of the Commonwealth Transportation Board (CTB) is sought for the commemorative naming of the roundabout at the intersection of Route 634, Allin Road, and Route 630, Jefferson Park Road and Bull Hill Road, Prince George County as the "Ozbat Circle", requested by Prince George County.

Facts: The Prince George County Board of Supervisors enacted a resolution on March 27, 2018 memorializing the life and service of Captain Jesse A. Ozbat, who passed away on May 20, 2012. Based on that resolution, Captain Jesse A. Ozbat was a 2002 graduate of Prince George County High School and an active member of the United States Army JROTC Battalion. He was a 2006 graduate of Virginia State University earning his commission on May 13, 2006 upon graduation.

Serving during Operation Enduring Freedom, Captain Jesse A. Ozbat, assigned to the $168^{\text {th }}$ Brigade Support Battalion, $214^{\text {th }}$ Fires Brigade, Fort Sill, Oklahoma was mortally wounded on May 20, 2012 in Tarin Kowt, Afghanistan when enemy forces attacked his unit with an improvised explosive device.

Recommendations: The Virginia Department of Transportation (VDOT) recommends this request be approved.

Action Required by CTB: The Code of Virginia, § 33.2-213, requires a majority of the CTB members to approve a resolution naming a highway or bridge, as appropriate. A resolution will be provided for the CTB's consideration.

Result if Approved: The roundabout at the intersection of Route 634, Allin Road, and Route 630, Jefferson Park Road and Bull Hill Road, Prince George County will be named as the "Ozbat Circle", requested by Prince George County. In accordance with § 33.2-213 of the Code of Virginia, Prince George County agrees to pay the costs of producing, placing, and maintaining the signs calling attention to this naming.

Options: Approve, Deny, or Defer.
Public Comments/Reactions: VDOT is not aware of any opposition to this proposal.

AUTHORIZATION TO SUBMIT TO VDOT A REQUEST TO NAME THE ROUNDABOUT AT THE ENTRANCE OF FORT LEE GATE A, ROUTE 634 (ALLIN ROAD) AND ROUTE 630 (JEFFERSON PARK ROAD AND BULL HILL ROAD) FOR CPT. JESSE A. OZBAT (ARMY)

WHEREAS, Captain Jesse A. Ozbat was a 2002 graduate of Prince George County High School and active member of the U.S. Army JROTC Battalion; and

WHEREAS, Captain Jesse A. Ozbat was a 2006 graduate of Virginia State University receiving a full academic scholarship and earned his commission on May 13, 2006 upon graduation; and

WHEREAS, LTC Alvin S. Chandler of the Prince George County Junior ROTC has presented for consideration before the Board of Supervisors a request to have a road segment in Prince George County, Virginia named after Cpt. Jesse A. Ozbat, who served in the U.S. Army until May 20, 2012; and

WHEREAS, serving during Operation Enduring Freedom, Cpt. Jesse A. Ozbat, 28, of Prince George, Virginia, assigned to 168 th Brigade Support Battalion, 214th Fires Brigade, Fort Sill, Oklahoma died May 20, 2012 in Tarin Kowt, Afghanistan, of wounds suffered when enemy forces attacked his unit with an improvised explosive device. Also killed was Army 2nd Lt. Tobias C. Alexander; and

WHEREAS, the Board of Supervisors of Prince George County agree to work with the Prince George County Junior ROTC to raise funds for the placement of the appropriate marker; and

NOW, THEREFORE, BE IT RESOLVED That the Board of Supervisors of the County of Prince George this $27^{\text {th }}$ day of March, 2018, hereby authorizes a request to VDOT to name the roundabout at the entrance of Fort Lee Gate A, Route 634 (Allin Road) and Route 630 (Jefferson Park Road and Bull Hill Road) in memory of Cpt. Jesse A. Ozbat. That "Ozbat Circle" shall always signify the strong bond between Fort Lee and Prince George County; and

BE IT FURTHER RESOLVED That the County Administrator is authorized to sign any required agreements on behalf of the County.
