

DRAFT MINUTES MEETING OF THE INTERSTATE I-81 COMMITTEE

The first meeting of the I-81 Committee was held at the Hampton Inn in Lexington, Virginia. The meeting began at 2:05 PM on August 12, 2019. The meeting began with opening remarks from Shannon Valentine, Secretary of Transportation.

1. Nick Donohue, Deputy Secretary of Transportation presented on the roles and responsibilities of the Committee – Nick Donohue, Deputy Secretary of Transportation.

General discussion: Deputy Donohue discussed with the Committee the need for staff to receive guidance on policy goals related to the prioritization of projects along the corridor. There was Committee discussion related to funding projects in each of the three VDOT districts and if they should be funded from the top down, based on score. Further discussion was related to having flexibility for projects and the need to consider which ones have the most benefit and equity considerations when advising on which projects to fund first.

2. John Lawson, Deputy Secretary of Transportation presented the financial overview. Referenced by the attached presentation

General Discussion: The Committee discussed options for financing projects to include pay-as-you-go and bonding which would require action by the General Assembly. General discussion on the potential for bonding to help deliver projects sooner.

3. Bart Thrasher, Chief Engineer Virginia Department of Transportation presented the project prioritization process.

General Discussion: The Committee was briefed on operational improvements that began July 1, 2019 and requested a list of these projects, 16 operational projects began and 47 capital improvements remain. The Committee requested VDOT to prepare a draft schedule and plan for the remaining capital improvement projects at the next meeting. The Committee requested that lead time be addressed and required environmental reviews. There was continued discussion on potential funding options. The Committee requested that staff to further explore bond financing to get projects constructed sooner and leverage funds to maximize bonding.

4. Delegate Terry Austin, Chairman of the Committee gave closing remarks and opened the floor for public comment. The next meeting date was deferred.
