Title: Revenue Sharing De-allocation of Project Funds (Statewide)

WHEREAS, § 33.2-357 of the *Code of Virginia* (1950), as amended ("Va. Code"), prescribes that from funds made available by the General Assembly, the Commonwealth Transportation Board ("CTB") may make an equivalent matching allocation to any locality for the improvement, construction, or reconstruction of the highway systems within such locality; and

WHEREAS, pursuant to § 33.2-357 of the *Va. Code*, "any revenue-sharing funds for projects not initiated after two subsequent fiscal years of allocation may be reallocated at the discretion of the Commonwealth Transportation Board"; and

WHEREAS, § 33.2-357 of the *Va. Code* stipulates that the funds allocated by the CTB under this section "shall be distributed and administered in accordance with the revenue-sharing program guidelines established by the Board"; and

WHEREAS, at its December 5, 2018 meeting, the CTB adopted its revision of the Revenue Sharing Program Policy and Guidelines, and the process for de-allocation of revenue-sharing program funds for projects not initiated after two subsequent fiscal years of the allocation is described within these guidelines; and

WHEREAS, in accordance with the approved de-allocation process, projects that meet the criteria for de-allocation or are cancelled at the request of the locality, have been identified and affected localities have received written notification of the Virginia Department of Transportation's intent to remove the Revenue Sharing Program funds from identified projects for the purpose of reallocation by the CTB; and

WHEREAS, "Attachment A," which is made a part of this Resolution, lists all projects and respective Revenue Sharing Program funding to be de-allocated and the funding amount indicated to be returned to the statewide Revenue Sharing account for distribution.

NOW, THERFORE, BE IT RESOLVED, that the Commonwealth Transportation Board hereby approves the de-allocation of funding from projects as set forth in the "Attachment A" listing.

CTB Decision Brief

Revenue Sharing De-Allocation of Project Funds (Statewide)

Issue: As stipulated in § 33.2-357 of the *Code of Virginia*, any projects having funds allocated under the revenue sharing program shall be initiated within two subsequent years of the allocation or those funds may be reallocated at the discretion of the Commonwealth Transportation Board (CTB). The Revenue Sharing Program Policy and Guidelines (Guidelines), as approved by the CTB, establish circumstances when project funds may be deallocated due to cancellation of projects, project inactivity, or surplus allocations on completed projects. Accordingly, the Virginia Department of Transportation (Department) has prepared a list of projects which meet de-allocation/reallocation conditions set forth in § 33.2-357, CTB Policy, and in the Guidelines and recommends that the funding previously allocated to these projects be de-allocated by the CTB and made available in the Revenue Sharing account for reallocation statewide.

Facts: The de-allocation process is described within the Revenue Sharing Program Guidelines, revised and adopted by the CTB at its December 5, 2018 meeting. In adherence with the process, the Department conducted a review of all revenue sharing projects that had no expenditures within the last twenty-four months, or had been completed for six months or more with a surplus balance. Projects meeting the de-allocation criteria were identified, and a list of those projects was provided to each locality to offer input regarding the status of the project in order for the Department to determine if the funds should be retained or de-allocated. Based on this input, the Department has prepared a final list of projects which are intended to have funding de-allocated and made available for reallocation statewide, subject to the approval of the CTB.

Recommendation: The Department recommends that the allocations/funding shown on "Attachment A" be de-allocated from the projects specified in Attachment A and returned to the statewide Revenue Sharing account so that they are available for re-allocation.

Action Required by CTB: The *Code of Virginia* and the CTB's Revenue Sharing Program Guidelines specify that the CTB shall approve the de-allocation of identified funds that meet the criteria set forth in the de-allocation process. A resolution is provided for a formal vote.

Result, if Approved: One-hundred sixteen (116) projects, totaling \$16,899,465, identified on the "Attachment A" listing will have funds de-allocated and returned to the statewide Revenue Sharing account rendering them available for reallocation.

Options: Approve, Deny, or Defer.

WHEREAS, Section 33.2-214(B) of the *Code of Virginia* requires the Commonwealth Transportation Board (Board) to adopt by July 1st of each year a Six-Year Improvement Program (Program) of anticipated projects and programs and that the Program shall be based on the most recent official revenue forecasts and a debt management policy; and

WHEREAS, after due consideration the Board adopted a Final Fiscal Years 2019-2024 Program on June 20, 2018; and

WHEREAS, the Board is required by §§ 33.2-214(B) and 33.2-221(C) of the *Code of Virginia* to administer and allocate funds in the Transportation Trust Fund; and

WHEREAS, § 33.2-214(B) of the *Code of Virginia* provides that the Board is to coordinate the planning for financing of transportation needs, including needs for highways, railways, seaports, airports, and public transportation and is to allocate funds for these needs pursuant to §§ 33.2-358 and 58.1-638 of the *Code of Virginia*, by adopting a Program; and

WHEREAS, § 58.1-638 authorizes allocations to local governing bodies, transportation district commissions, or public service corporations for, among other things, capital project costs for public transportation and ridesharing equipment, facilities, and associated costs; and

WHEREAS, the projects shown in Appendix A were not included in the FY 2019-2024 Program adopted by the Board on June 20, 2018; and

WHEREAS, the Board recognizes that the projects are appropriate for the efficient movement of people and freight and, therefore, for the common good of the Commonwealth.

NOW THEREFORE, BE IT RESOLVED, by the Commonwealth Transportation Board, that the projects shown in Appendix A are added to the Six-Year Improvement Program of projects and programs for Fiscal Years 2019 through 2024 and are approved.

CTB Decision Brief

Addition of Projects to the Six-Year Improvement Program for Fiscal Years 2019 - 2024

Issue: Each year the Commonwealth Transportation Board (CTB) must adopt a Six-Year Improvement Program (Program) and allocations in accordance with the statutory formula.

Facts: The CTB must adopt a Program of anticipated projects and programs by July 1st of each year in accordance with § 33.2-214(B) of the *Code of Virginia*. On June 20, 2018, after due consideration, the CTB adopted a Final FY 2019-2024 Program. The projects shown in Appendix A were not in the Final FY 2019-2024 Program adopted by the CTB.

Recommendations: The Virginia Department of Transportation (VDOT) recommends the addition of the projects in Appendix A to the Program for FY 2019–2024.

Action Required by CTB: The CTB will be presented with a resolution for a formal vote to add the projects listed in Appendix A to the Program for FY 2019–2024 to meet the CTB's statutory requirements.

Result, if Approved: If the resolution is approved, the projects listed in Appendix A will be added to the Program for FY 2019-2024.

CTB Decision Brief

FY2019-2024 Six-Year Improvement Program Transfers for November 19, 2018 through December 13, 2018

Issue: Each year the Commonwealth Transportation Board (CTB) must adopt a Six-Year Improvement Program (Program) in accordance with statutes and federal regulations. Throughout the year, it may become necessary to transfer funds between projects to have allocations available to continue and/or initiate projects and programs adopted in the Program.

Facts: On June 20, 2018, the CTB granted authority to the Commissioner of Highways (Commissioner), or his designee, to make transfers of allocations programmed to projects in the approved Six-Year Improvement Program of projects and programs for Fiscal Years 2019 through 2024 to release funds no longer needed for the delivery of the projects and to provide additional allocations to support the delivery of eligible projects in the approved Six-Year Improvement Program of projects and programs for Fiscal Years 2019 through 2024 consistent with Commonwealth Transportation Board priorities for programming funds, federal/state eligibility requirements, and according to the following thresholds based on the recipient project:

The CTB will be presented with a resolution for formal vote to approve the transfer of funds exceeding the established thresholds. The list of transfers from November 9, 2018 through December 13, 2018 is attached.

Recommendations: VDOT recommends the approval of the transfers exceeding the established thresholds from donor projects to projects that meet the CTB's statutory requirements and policy goals.

Action Required by CTB: The CTB will be presented with a resolution for a formal vote to adopt changes to the Program for Fiscal Years 2019 – 2024 that include transfers of allocated funds exceeding the established thresholds from donor projects to projects that meet the CTB's statutory requirements and policy goals.

Result, if Approved: If approved, the funds will be transferred from the donor projects to projects that meet the CTB's statutory requirements and policy goals.

Title: Limited Access Control Change (LACC) Route 171 (Victory Boulevard) York County

WHEREAS, Oyster Point Road (Proposed Route 171 Extension) now Route 171 (Victory Boulevard), State Highway Project 0171-099-102, RW-201, York County was designated as a Limited Access Highway by the Commonwealth Transportation Board (CTB), on April 16, 1987; and

WHEREAS, in connection with State Highway Project 0171-099-102, RW-201, the Commonwealth acquired certain limited access control easements from Marshall W. Cook, by Instrument dated November 4, 1987, recorded in Deed Book 507, Page 241 and concluded by Order dated May 21, 1991, both recorded in the Office of the Clerk of Circuit Court of the County of York; and

WHEREAS, Landbridge Acquisitions, LLC has requested a break in limited access control along Route 171 (Victory Boulevard) to construct a commercial entrance to serve as direct access to and from their planned senior housing development, Phoenix at Yorktown, onto the existing limited access right of way of Route 171 (Victory Boulevard), approximately 860 feet west of the Route 171 and Route 17 Intersection; and

WHEREAS, the requested break is approximately 89 feet, along the centerline alignment of Route 171, as shown on the attached Exhibit A, showing the proposed break in the current limited access control line, and Exhibit B, showing the proposed entrance and its intersection with Route 17, all as shown on the plans for State Highway Project, 0171-099-102, RW-201; and

WHEREAS, the County of York, by resolution, R-17-115, adopted August 15, 2017, endorses the LACC; and

- WHEREAS, VDOT's Hampton Roads District has determined, with the Chief Engineer concurring, that the proposed break in the limited access control of Route 171 will have minimal impact on the operation of the Route 171 right of way, and the proposed LACC is appropriate from a safety and traffic control standpoint based upon a Global Traffic Analysis, dated November 14, 2016, prepared by DRW Consultants, LLC; and
- **WHEREAS**, VDOT's Hampton Roads District has determined the location of the proposed LACC is not within an air quality maintenance or non-attainment area. In addition, the environmental impact analysis was reviewed and approved by the Hampton Roads District and there will be no adverse environmental impacts; and
- **WHEREAS**, public notices of willingness to hold a public hearing and to receive public comment were posted in the *Daily Press* newspaper on October 20, 2017 and October 27, 2017, with no comments or requests for a public hearing received; and
- **WHEREAS**, compensation shall be paid by the requestor in consideration of the LACC and the related easements to be conveyed, as determined by the Commissioner of Highways or his designee; and
- WHEREAS, all right of way, engineering, construction, and necessary safety improvements shall meet all VDOT standards and requirements; and
- WHEREAS, all costs of engineering and construction, including all necessary safety improvements, will be borne by the requestor; and
- **WHEREAS**, the requestor will be required to obtain a Land Use Permit prior to any activity within the Route 171 limited access right of way.
- **NOW, THEREFORE, BE IT RESOLVED,** in accordance with Section 33.2-401 of the *Code of Virginia* and 24 *Virginia Administrative Code* 30-401--10 et seq., the CTB hereby finds and concurs with the determinations of VDOT, and approves said LACC, as set forth herein, subject to the above referenced conditions.
- **BE IT FURTHER RESOLVED,** the Commissioner of Highways is authorized to take all actions and execute any and all documents necessary to implement such changes.

CTB Decision Brief Route 171 (Victory Boulevard) County of York Limited Access Control Change

Issues: Landbridge Acquisitions, LLC has requested a break in limited access control along Route 171 (Victory Boulevard) to construct a commercial entrance to serve as direct access to and from their planned senior housing development, Phoenix at Yorktown, onto the existing limited access right of way of Route 171 (Victory Boulevard), approximately 860 feet west of the Route 171 and Route 17 Intersection. This limited access control change requires approval of the Commonwealth Transportation Board (CTB) pursuant to § 33.2-401 of the *Code of Virginia* and 24 VAC 30-401-20 of the *Virginia Administrative Code*

Facts:

- Oyster Point Road (Proposed Route 171 Extension) now Route 171 (Victory Boulevard), State Highway Project 0171-099-102, RW-201, C-501, York County was designated as a Limited Access Highway by the Commonwealth Transportation Board (CTB), on April 16, 1987.
- In connection with State Highway Project 0171-099-102, C-501, RW-201, the Commonwealth acquired certain limited access control easements from Marshall W. Cook, by Instrument dated November 4, 1987, recorded in Deed Book 507, Page 241 and concluded by Order dated May 21, 1991, both recorded in the Office of the Clerk of Circuit Court of the County of York.
- The proposed break is from a point 78.80 feet right of Station 228+57.48 (Proposed. Relocated Oyster Point Road centerline) to a point 176.05 feet right of Station 229+46.72 (Proposed Relocated Oyster Point Road centerline) for a connection to the eastbound lane (EBL) of Route 171.
- The proposed break is also approximately 89 feet, along the centerline alignment of Route 171, as shown on the plans for State Highway Project, 0171-099-102, RW-201, C-501 (Limited Access Control Change or LACC), and includes the addition of a right turn lane on eastbound Route 171, a left turn lane on westbound Route 171, an extension of the left turn lane on eastbound route 171 into Wal-Mart and modification of the existing signal, with both left and right in and left and right out and no through movements.
- The written determination of the Chief Engineer regarding this proposed project is attached for your consideration.
- The County of York, by resolution, R-17-115, adopted August 15, 2017, endorses the LACC.
- VDOT's Hampton Roads District has determined, with the Chief Engineer concurring, that the proposed break in the limited access control of Route 171 will have minimal impact on the operation of the Route 171 right of way, with a projected increased delay at the Wal-Mart/Victory Boulevard intersection of only one second on average, and the proposed LACC is appropriate from a safety and traffic control standpoint based upon a Global Traffic Analysis, dated November 14, 2016, prepared by DRW Consultants, LLC.
- VDOT's Hampton Roads District has determined the location of the proposed LACC is not within an air quality maintenance or non-attainment area. In addition, the environmental impact analysis was reviewed and approved by the Hampton Roads District and there will be no adverse environmental impacts.
- Public notices of willingness to hold a public hearing and to receive public comment were posted in the *Daily Press* newspaper on October 20, 2017 and October 27, 2017, with no comments or requests for a public hearing received.
- Compensation shall be paid by the requestor in consideration of the LACC and the related easements to be conveyed, as determined by the Commissioner of Highways or his designee.

- All right of way, engineering, construction, and necessary safety improvements shall meet all VDOT standards and requirements.
- All costs of any engineering, construction or safety improvements will be borne by the requestor.
- The requestor will be required to obtain a Land Use Permit prior to any activity within the Route 171 limited access right of way.

Recommendation: VDOT recommends the approval of the proposed LACC subject to the referenced conditions and facts. VDOT further recommends that the Commissioner be authorized to take all actions and execute all documentation necessary to implement the LACC.

Action Required by CTB: Virginia Code § 33.2-401 and 24 *Virginia Administrative Code* 30-401--10 et seq. requires a majority vote of the CTB approving the recommended LACC. The CTB will be presented with a resolution for a formal vote.

Result, if Approved: The project will move forward as proposed and the Commissioner of Highways will be authorized to take all actions necessary to comply with this resolution.

Options: Approve, Deny, or Defer.

WHEREAS, in accordance with the statutes of the Commonwealth of Virginia and policies of the Commonwealth Transportation Board, a Design Public Hearing was held in the Lutrelle F. Palmer Elementary School on February 23, 1987, at 7:00 p.m. for the purpose of considering the proposed major design features of Oyster Point Road (Proposed Route 171 Extension) from the intersection of Jefferson Avenue in Newport News to Int. Route 17 in York County, State Projects U000-121-108, C502; 0064-121-105, C501; and 0171-099-102, C501; Federal Projects M-5122 () and IR-64-3(),

WHEREAS, proper notice was given in advance and all those present were given a full opportunity to express their opinions and recommendations for or against the proposed projects as presented, and their statements being duly recorded, and

WHEREAS, the economic, social and environmental effects of the proposed projects have been examined and given proper consideration, and this evidence, along with all other, has been carefully reviewed,

NOW, THEREFORE, BE IT RESOLVED, that the major design features of these projects be approved in accordance with the plan as proposed and presented at the said Design Public Hearing by the Department's Engineers, and

BE IT FURTHER RESOLVED, that in accordance with the Code of Virginia and Commonwealth Transportation Board Policy, access is granted to Interstate Route 64 for Oyster Point Road as shown on the plans presented at the Design Public Hearing, and

BE IT FURTHER RESOLVED, that in accordance with the Code of Virginia and Commonwealth Transportation Board Policy, Oyster Point Road be designated as a limited access highway from Canon Boulevard in the City of Newport News to Route 17 in York County with access to Interstate Route 64 in Newport News and two access points in York County for proposed development, and

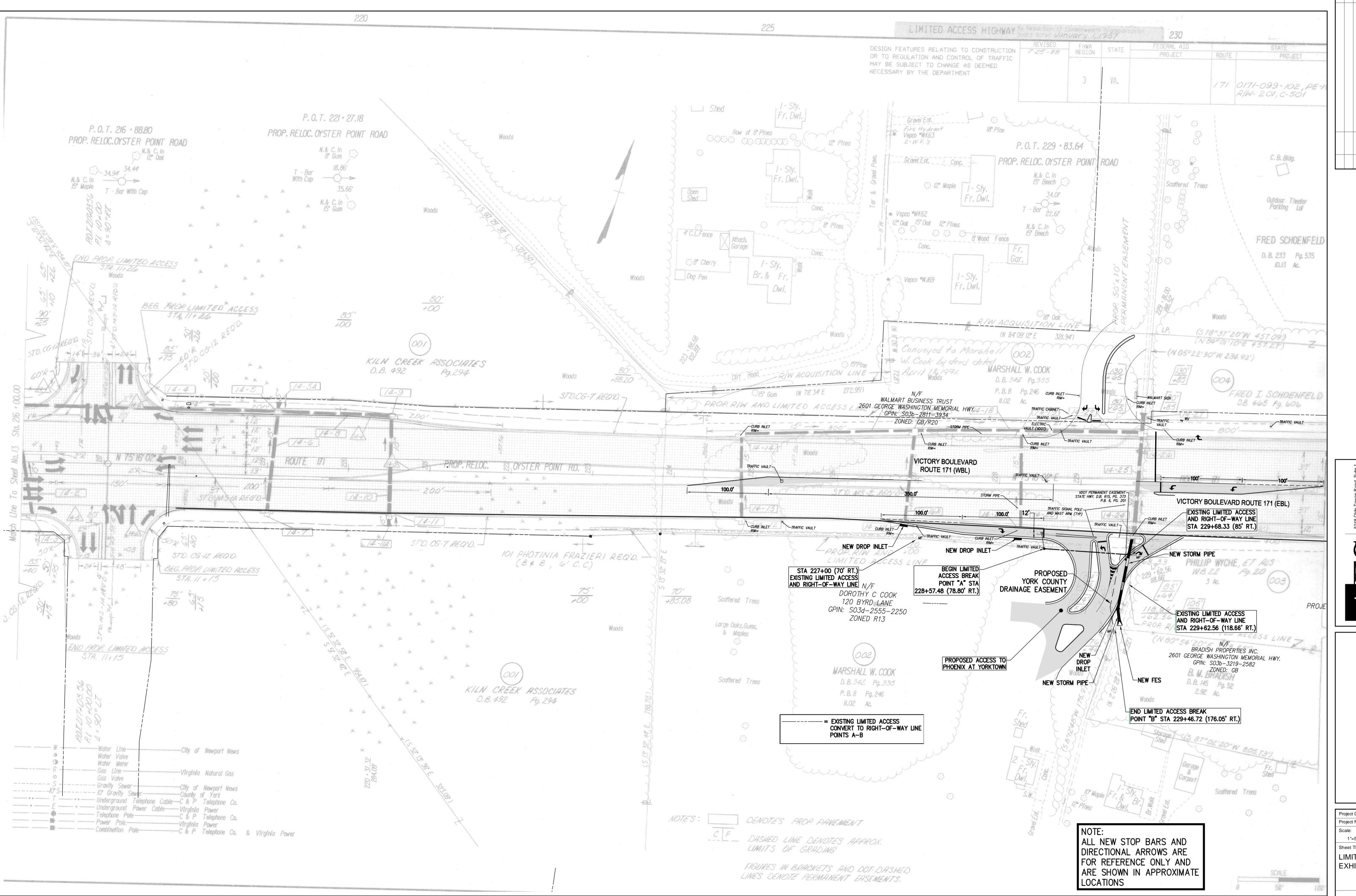

Issue: Approval of the Commonwealth Transportation Board (CTB) is sought for the commemorative naming of Route 803, Ball Hollow Road, from its intersection with Route 624 to the end of state maintenance (approximately 0.1 mile) in Russell County as the "Brandon Looney Memorial Highway", as requested by Russell County.






ROUTE 803 – RUSSELL COUNTY LOCATION & LIMITS OF NAMING

Title: Designation of the I-95 Express Lanes

Fredericksburg Extension as HOT Lanes and Authorization for the Commissioner of Highways to Enter into an Updated Memorandum of Understanding with the Federal Highway Administration Concerning Tolling of the I-95 HOV/HOT Lanes, as Extended.

WHEREAS, pursuant to the Public-Private Transportation Act of 1995 (the "PPTA"), (Va. Code §§ 33.2-1800, *et seq.*), the Virginia Department of Transportation (the "Department") may allow private entities to develop and/or operate qualifying transportation facilities; and

WHEREAS, on July 31, 2012, pursuant to the PPTA, the Department and 95 Express Lanes, LLC entered into a comprehensive agreement (the "Comprehensive Agreement") relating to the I-95 HOV/HOT Lanes Project to develop, design, finance, construct, maintain, and operate 29 continuous miles of High Occupancy Toll ("HOT") lanes on Interstates 95 and 395 between Turkeycock Run (milepost 2.0 on Interstate 395) and Garrisonville Road (VA Route 610) (the "Original 95 HOT Lanes"); and

WHEREAS, on May 2, 2016, the Department entered into the First Amendment to the Comprehensive Agreement to extend the HOT lanes on Interstate 95 south 2.2 miles (near milepost 142.5 on Interstate 95) (the "I-95 Express Lanes Southern Terminus Extension"); and

WHEREAS, on June 8, 2017, the Department entered into the Amended and Restated Comprehensive Agreement (the "First ARCA") to extend the HOT lanes on Interstate 395 for approximately 8 miles north to the Washington D.C. line (the "I-395 Express Lanes Northern Extension"); and

WHEREAS, the Department anticipates amending and restating the First ARCA to extend the HOT lanes on Interstate 95 approximately ten additional miles farther south to Route 17 in Fredericksburg (the "I-95 Express Lanes Fredericksburg Extension"); and

WHEREAS, Va. Code § 33.2-502 provides that the Commonwealth Transportation Board (the "CTB") may designate one or more lanes of any highway including lanes previously classified as High Occupancy Vehicle ("HOV") lanes, in the Interstate System, primary state highway system, or National Highway System, or any portion thereof, as HOT lanes; and

WHEREAS, pursuant to Va. Code § 33.2-502, in making HOT lanes designations, the CTB is required to also specify the high-occupancy requirement and conditions for use of such HOT lanes or may authorize the Commissioner of Highways to make such determination consistent with the terms of a comprehensive agreement executed pursuant to Va. Code § 33.2-1808, however, the high-occupancy requirement for a HOT lanes facility constructed or operated as a result of the PPTA shall not be less than three; and

WHEREAS, by Resolution dated September 17, 2014, the CTB designated as HOT lanes the Original 95 HOT Lanes; and

WHEREAS, by Resolution dated February 16, 2017, the CTB designated as HOT lanes both the (i) I-95 Express Lanes Southern Terminus Extension, and (ii) I-395 Express Lanes Northern Extension; and

WHEREAS, the Department intends for the I-95 Express Lanes Fredericksburg Extension to be tolled using congestion pricing.

WHEREAS, pursuant to authority granted by the CTB on February 16, 2017, the Department entered into a memorandum of understanding with the Federal Highway Administration ("FHWA") on April 10, 2017 (the "Existing Toll MOU") permitting the Department to toll certain HOT lanes on Interstates 95 and 395 from I-395 just south of the Washington D.C. line, at the northern terminus, to approximately mile marker 142.5 on I-95, approximately 0.9 miles south of the Garrisonville Road overpass, at the southern terminus (the "Existing 95/395 Toll Facility"); and

WHEREAS, given the Department's intention to extend and expand the Existing 95/395 Toll Facility ten miles farther south to Route 17 in Fredericksburg (the entire span from Route 17

to just south of the Washington D.C. line hereinafter referred to as the "Extended 95/395 Toll Facility") the FHWA requires the Department to enter into a tolling memorandum of understanding governing tolling for the Extended 95/395 Toll Facility (the "Updated Toll MOU"), attached hereto as Attachment A, to replace the Existing Toll MOU; and

WHEREAS, the Updated Toll MOU will require the Department to comply with mandatory federal requirements related to tolling and applicable to the Extended 95/395 Toll Facility; and

WHEREAS, the CTB is authorized under Va. Code § 33.2-221(A) to enter into contracts and agreements with the United States government.

- **NOW, THEREFORE, BE IT RESOLVED** that the CTB hereby designates the I-95 Express Lanes Fredericksburg Extension as HOT lanes in accordance with Va. Code § 33.2-502, to be implemented upon issuance of a "Service Commencement Notice to Proceed" pursuant to the First ARCA, as amended and restated.
- **BE IT FURTHER RESOLVED** that the CTB hereby specifies the high-occupancy requirement for the I-95 Express Lanes Fredericksburg Extension as HOV-3, in accordance with Va. Code § 33.2-502, to be implemented upon issuance of a "Service Commencement Notice to Proceed" pursuant to the First ARCA, as amended and restated.
- **BE IT FURTHER RESOLVED** that the CTB hereby authorizes the Commissioner of Highways to establish the conditions for use of the I-95 Express Lanes Fredericksburg Extension in accordance with the terms and conditions of the First ARCA, as amended and restated.
- **BE IT FURTHER RESOLVED** that the CTB hereby authorizes the Commissioner of Highways to execute the Updated Toll MOU between the Department and FHWA, governing the tolling of the Extended 95/395 Toll Facility, in the form set out as Attachment A, with such changes as the Commissioner deems necessary or appropriate.

Designation of the I-95 Express Lanes Fredericksburg Extension as HOT Lanes and Authorization for the Commissioner of Highways to Enter into an Updated Memorandum of Understanding with the Federal Highway Administration Concerning Tolling of the I-95 HOV/HOT Lanes, as Extended.

Issue: The Virginia Department of Transportation (the "Department") intends to amend and restate the Amended and Restated Comprehensive Agreement ("First ARCA") relating to the Interstate 95 and 395 High Occupancy Toll ("HOT") Lanes to extend the HOT lanes on Interstate 95 approximately ten miles farther south to Route 17 in Fredericksburg (the "I-95 Express Lanes Fredericksburg Extension"). Given the Department's intention to extend and expand the HOT/Express lanes on I-95, the Federal Highway Administration ("FHWA") requires the Department to enter into/execute an updated tolling memorandum of understanding governing tolling for the extended I- 95/395 toll facility (the "Updated Toll MOU"), to replace the existing Memorandum of Understanding relating to tolling on the existing I-95/395 toll facility.

Pursuant to Va. Code § 33.2-502, the Department is requesting the Commonwealth Transportation Board (the "CTB") to designate the I-95 Express Lanes Fredericksburg Extension as HOT lanes with a high-occupancy requirement of three or more. Further, pursuant to Va. Code § 33.2-221 (A), the Department is requesting authorization for the Commissioner of Highways to enter into the Updated Toll MOU with FHWA.

Facts:

- On July 31, 2012, pursuant to the Public-Private Transportation Act of 1995 ("PPTA"), (Va. Code §§ 33.2-1800, *et seq.*), the Department and 95 Express Lanes, LLC entered into the Comprehensive Agreement to develop, design, finance, construct, maintain, and operate 29 continuous miles of HOT lanes on Interstates 95 and 395 (the "Original 95 HOT Lanes").
- On May 2, 2016, the Department entered into an amendment (the "First Amendment") to the Comprehensive Agreement to extend the I-95 HOT Lanes south 2.2 miles by constructing one reversible HOT lane and adding new HOT lane access points (the "I-95 Express Lanes Southern Terminus Extension").
- On June 8, 2017, the Department entered into the First ARCA to extend HOT lanes on I-395 for approximately 8 miles north to the Washington DC line ("I-395 Express Lanes Northern Extension").
- The Department now anticipates amending and restating the First ARCA to add the I-95 Express Lanes Fredericksburg Extension.
- The Department intends for the I-95 Express Lanes Fredericksburg Extension to be tolled using congestion pricing.

Designation of I-95 Express Lanes Fredericksburg Extension as HOT Lanes

- By resolution dated September 17, 2014, the CTB designated as HOT lanes the Original 95 HOT Lanes.
- By Resolution dated February 16, 2017, the CTB designated as HOT lanes both (i) the I-95 Express Lanes Southern Terminus Extension, and (ii) the then-anticipated I-395 Express Lanes Northern Extension.

- On April 10, 2017, FHWA and the Department entered into a memorandum of understanding (the "Existing Toll MOU") permitting the Department to toll certain HOT lanes on Interstates 95 and 395 from I-395 just south of the Washington D.C. line, at the northern terminus, to approximately mile marker 142.5 on I-95, approximately 0.9 miles south of the Garrisonville Road overpass, at the southern terminus (the "Existing 95/395 Toll Facility").
- Given the Department's intention to extend and expand the Existing 95/395 Toll Facility ten miles farther south to Route 17 in Fredericksburg (the entire span from Route 17 to just south of the Washington D.C. line hereinafter referred to as the "Extended 95/395 Toll Facility") the FHWA requires the Department to enter into a tolling memorandum of understanding governing tolling for the Extended 95/395 Toll Facility (the "Updated Toll MOU"), attached hereto as Attachment A, to replace the Existing Toll MOU.
- The Updated Toll MOU will require the Department to comply with mandatory federal requirements related to tolling and applicable to the Extended 95/395 Toll Facility.
- The CTB is authorized under Va. Code § 33.2-221(A) to enter into contracts and agreements with the United States government.

Recommendation: that the CTB (1) designate the I-95 Express Lanes Fredericksburg Extension as HOT Lanes, in accordance with Va. Code §33.2-502, to be implemented upon issuance of a "Service Commencement Notice to Proceed" pursuant to the First ARCA, as amended and restated; (2) specify the high-occupancy requirement for the I-95 Express Lanes Fredericksburg Extension as HOV-3, in accordance with Va. Code §33.2-502, to be implemented upon issuance of a "Service Commencement Notice to Proceed" pursuant to the First ARCA, as amended and restated; (3) authorize the Commissioner of Highways to establish the conditions for use of the I-95 Express Lanes Fredericksburg Extension in accordance with the terms and conditions of the First ARCA, as amended and restated; and (4) authorize the Commissioner of Highways to execute the Updated Toll MOU with FHWA for the Extended 95/395 Toll Facility.

Action Required by CTB: Section 33.2-502 requires a majority vote of the CTB adoption or approving the recommended actions. The CTB will be presented with a resolution for a formal vote.

Result, if Approved: The I-95 Express Lanes Fredericksburg Extension will be designated as HOT lanes with a high occupancy requirement of three or more, in accordance with Va. Code § 33.2-502, to be implemented upon issuance of a "Service Commencement Notice to Proceed" pursuant to the First ARCA, as amended and restated; the Commissioner of Highways will be authorized to establish the conditions for use of the I-95 Express Lanes Fredericksburg Extension in accordance with the terms and conditions of the First ARCA, as amended and restated; and the Commissioner of Highways will be authorized to execute the Updated Toll MOU with FHWA.

AMENDED AND RESTATED MEMORANDUM OF UNDERSTANDING (MOU) BETWEEN THE

FHWA VIRGINIA DIVISION OFFICE (DIVISION) AND THE VIRGINIA DEPARTMENT OF TRANSPORTATION (VDOT)

WHEREAS, on April 10, 2017, the FHWA and VDOT entered into a memorandum of understanding (the "Existing Toll MOU") permitting VDOT to toll the high occupancy vehicle ("HOV") lanes facility on Interstates 95 and 395 from approximately I-395 just south of the Washington D.C. line, at the northern terminus, to approximately mile marker 142.5 on I-95 in Stafford County, at the southern terminus, including the Phase VIII HOV-only lanes and HOV connector ramps through the Springfield Interchange (the "Existing Facility"); and

WHEREAS, VDOT desires to extend and expand the Existing Facility 10 miles farther south to approximately I-95 mile marker 133 (the entire span from mile marker 133 to just south of the Washington D.C. line hereinafter referred to as the "Toll Facility"); and

WHEREAS, based on the Existing Toll MOU, VDOT has previously implemented or plans to implement tolls using a congestion pricing toll strategy on the Existing Facility and now also desires to implement tolls using a congestion pricing toll strategy on the portion of the Existing Facility to be extended and expanded farther south to approximately I-95 mile marker 133, such that tolling using a congestion pricing toll strategy will eventually be implemented on the entirety of the Toll Facility; and

WHEREAS, the FHWA and VDOT desire to enter into this Amended and Restated MOU to reflect the mutual understanding that 23 U.S.C. 129(a) and 23 U.S.C. 166, HOV to HOT conversion applies to the entirety of the Toll Facility; and

WHEREAS, 23 U.S.C. 166(b)(4), as amended by the FAST Act, provides that a public authority may allow vehicles not otherwise exempt pursuant to 23 U.S.C. 166(b) to use a HOV facility by paying a toll.

NOW THEREFORE, the FHWA and VDOT hereby agree as follows:

- 1. The Toll Facility meets the toll eligibility requirements of 23 U.S.C. 166.
- 2. VDOT shall comply with all requirements of 23 U.S.C. 129(a) and 23 U.S.C. 166, as amended by the FAST Act, with respect to the Toll Facility. VDOT shall also ensure compliance with these requirements through appropriate contractual arrangements with a private operator of the Toll Facility.
- 3. The Existing Toll MOU is hereby amended and restated to apply to the entirety of the Toll Facility and replaced with this Amended and Restated MOU.

Frederick County

This project combines Smart Scale Round 2 (UPC 111060) with an existing secondary road project (UPC 59259) to provide a comprehensive road reconstruction and intersection improvements for 1.07 miles on Route 655, beginning at the intersection with Route 50. The project adds turn lanes at Route 50 and at Route 656, improves the vertical and horizontal alignment, and corrects sight distance deficiencies at Route 656. The project also includes a unique three-sided box culvert, built in phases over the existing box floor, in order to minimize both traffic and stream impacts during construction.

Route 655 is located in eastern Frederick County with a current ADT of 6,500 vehicles per day (projected ADT of 11,600 ADT). As the primary access to the Frederick County landfill, the road will remain open (though will require frequent lane closures) for the duration of the project.

Fixed Completion Date: July 20, 2020



City of Newport News

The purpose of this project is to replace and widen the existing structurally deficient bridge on Route 173 (Denbigh Boulevard) over Rte. I-64 and CSXT in the City of Newport News along with minor approach roadway work in order to complete the required roadway tie-ins. The existing bridge structure was completed in 1965 as part of the original Rte. I-64 construction and during construction of this overpass. The bridge is an 850 feet long bridge structure and has a curb-to-curb width of approximately 48 feet. The existing bridge width provides for 4 – 12 foot travel lanes and 2-5 foot sidewalks on each side. The current Bridge Safety Inspection report for this structure notes the general condition rating for the Substructure as 4 (Poor) and the GCR for the Deck and Superstructure as 5 (Fair). Due to these conditions, the bridge structure is considered structurally deficient.

The replacement bridge structure will be 910 feet long and will provide 2 – 8'-6" sidewalks, 4 travel lanes and a 16 ft median for a rail face-to-face width of 87 ft. The proposed bridge structure will consist of six (6) prestressed concrete spans made continuous for live load and was designed to not preclude future widening of Rte. I-64 and to accommodate additional CSXT tracks. The bridge structure will be constructed in 2 stages which will allow for 2 lanes of traffic to be maintained at all times until the new bridge structure is complete. The functional classification for this roadway is noted as being a Urban Minor Arterial with a Design Speed is 40 MPH and a posted speed limit of 35 MPH and has a future ADT (2039) of 35,300.
