## **Title:** Commending John Malbon

**WHEREAS,** John Malbon served as a member of the Commonwealth Transportation Board representing the Hampton Roads District from 2014 to 2021, having been appointed for a full four year term and subsequently reappointed by Governor Terry McAuliffe; and

WHEREAS, Mr. Malbon brought to his tenure on the Board, a dedicated record of leadership in the private sector and public service in his community, serving or having served as Chairman and CEO of PAPCO Inc., senior vice president of World Fuel Services, board member of the Hampton Roads Community Foundation, Virginia Wesleyan College, and Townebank, cochair of the Envision Virginia Beach 2040 Committee, chairman of the board of directors for the Virginia Economic Development Partnership, chairman of Sentara Healthcare Board of Directors, president of Virginia Beach Vision, and member of the Resort Advisory Commission; and

WHEREAS, Mr. Malbon diligently and tirelessly has played a significant role in transportation for the Commonwealth, serving as a member of the Commonwealth Transportation Board, both in his representation of the Hampton Roads District and also in other significant roles, namely, as member of the Revenue-Sharing Program Study Committee and the Rail and Transit Subcommittee, as a member of the Hampton Roads Transportation Planning Organization, and as an ex-officio member of the Hampton Roads Transportation Accountability Commission; and

**WHEREAS,** in 2006, he was named King Neptune of the Virginia Beach Neptune Festival and in 2007, he was named First Citizen of Virginia Beach by the Virginia Beach
