Ms. Hanley asked how much money this costs.

Mr. Estes responded that over the past years the overall maintenance budget has grown 4 percent for the urban system. At distribution it changes slightly from town to city based on mileage.

Ms. Hanley asked if what we have is a pot of money, which changes based on the mileage in a locality.

Secretary Homer asked Mr. Estes to take a minute to explain the effort underway with cities and towns to develop a performance measurement. Secretary Homer felt this was important in light of Commissioner's Shucet's testimony today. VDOT spends approximately one point one billion dollars to maintain the infrastructure. We spend about a quarter of a billion dollars to cities and town and the two counties. Mr. Estes has been leading an effort for a year and a half now to bring commonality to definitions and to develop a needs based empirically based needs budget for cities and towns. So it is not 4% on what we spend last year, but more based on reality.

Mr. Estes referenced Senate Bill 563, which instructs VDOT to work with localities on their maintenance reporting and their performance based future needs. Working with VML, VDOT staff worked with representatives from various cities and town across the state on the reporting mechanism. In the past two years VDOT have just begun asking the cities and towns what they spent the money on VDOT provided. The first part of the bill puts in categorical reporting requirements to report on what maintenance money was spent on over a year. VDOT worked again with different localities to come up with a form to break out the different categories i.e., reconstructions, different types of maintenance, emergency snow removal, which could be used by small towns across the states as well as the large cities.

Ms. Hanley asked if there would be the same kind of analysis in terms of needs based regarding secondary roads maintained by VDOT.

Secretary Homer responded that the local effort is patterned on a three and a half year effort that VDOT undertook.

Ms. Hanley asked if we were going to have VDOT report on money spent on secondary roads.

Secretary Homer answered that we had this information at VDOT today.

Ms. Hanley responded that a decade ago, there used to be list on secondary road repairs that you could see. That list comforted citizens if they knew they were on the list and it was a really rational way to go about explaining how that happened. Often times we hear you paved that one (road) when there was nothing wrong with it at all.

Secretary Homer asked Mr. Estes if this statement could be built into his presentation.

Mr. Estes responded yes.
