

Legislative Briefing for the Commonwealth Transportation Board

February 20, 2008

During the 2008 legislative session, 2969 bills have been introduced in the General Assembly; currently 1268 bills are pending in both houses. We are currently tracking around 101 bills that relate to transportation. The General Assembly is scheduled to adjourn on March 8th and reconvene on April 16th to consider the Governor's amendments and vetoes. Provided below are some highlights from this session.

Abusive Driver Fees

• Two bills propose to repeal § 46.2-206.1 relating to the imposition of civil remedial fees on certain drivers. (HB 1243 and SB 1)

Access Management Regulations

Two bills propose to promulgate the access management standards in phases. Standards relating to principal arterial roads shall become effective on July 1, 2008 and are not subject to APA. Standards relating to minor arterial roads and collector roads shall become effective on October 1, 2009 and are subject to the requirements of APA. These bills have an emergency clause. (HB 1572 and SB 370)

Impact Fees

A bill proposes to limit proffers for residential rezonings to non-cash proffers starting July 1, 2009.
The bill expands the number of localities authorized to assess impact fees. In addition to roads, the
bill allows for impact fees to be assessed for schools, public safety facilities, and on all new
development. Sets maximum impact fees and requires reporting to the Commission on Local
Government. (SB 768)

Incident Management

• A bill proposes to improve the Commonwealth's incident management response by allowing law enforcement to move vehicles involved in accidents to the nearest exit ramp or public parking area to conduct an accident investigation. (HB 1302)

Overweight Vehicles

- A bill proposes to eliminate the 85-mile distance limit for coal truck permits. (HB 144)
- A bill proposes to require VDOT to work with DMV and representatives of other industries that own and/or operate overload and overweight vehicles, to review the current fee structure applied to these vehicles to determine if additional fees are needed. Based on this review, legislation regarding the fee structure shall be provided to the Governor and members of the Senate Finance and Transportation Committees and House Appropriations and Transportation Committees no later than December 1, 2008. These vehicles will be required to pay an annual overweight fee of \$265 from July 1, 2008 to June 30, 2009. (HB 1551)

Revenue Sharing

• Two bills propose to eliminate maintenance as an allowable activity for the use of revenue sharing funds and remove the limitation on the use of proffer funds being used for local matching funds. Clarifies minimum program funding as not less than \$15 million each fiscal year. (HB 111 and SB 99)

Tolls

• Two bills that are proposed prohibit the CTB from imposing or collecting tolls on any component of the Interstate Highway System that includes all or any portion of I-81 without prior approval from the General Assembly. Also, a private entity is prohibited from imposing tolls or users fees on any existing rural portion of I-81 without approval from the General Assembly. (HB 1516 and SB 754)
