Prior to the motion, Ms. Rae presented a briefing on the project, referenced by attachment of the briefing materials, and a general discussion ensued: Mr. Lester and Mr. Mitchel spoke in support and additionally acknowledged the prior work by Mr. Klinge and the Task Force; Mr. McCarthy spoke in support, but requested a follow-up regarding the DRPT budget, Six-Year Plan, and next level of activity beyond the preliminary engineering stage [Mr. Rae assured him of these procedures]; Mr. Watson spoke in support; Ms. Dragas spoke in support, but questioned the local financial support and price per rider estimates; Ms. Connally spoke in support and stated environmental and rural issues can be protected with rail; Mr. Bowie spoke in support, but requested a caveat that approval today would not be a commitment to go all the wayeach step would come back to the Board for approval [Ms. Rae assured him of this process]; Mr. Mitchel concurred with Mr. Bowie; Dr. Stone spoke in support, but urged continued cost comparisons with other systems.

Moved by Mr. Klinge, seconded by Mr. Mitchel. Motion carried, resolution approved.

- 5. VDOT Chief Engineer for Operations C. Frank Gee gave an overview of Asset Management.
