

Minutes of the Meeting of the State Highway
Commission of Virginia, Held in
Richmond, January 4, 1937.

On the morning of January 4th, 1937, the State Highway Commission, consisting of Messrs. H. G. Shirley, Wade H. Massie, Secretary, Wm. H. East, S. W. Rawls and J. F. Wyzor, met in their office, State Office Building, Richmond, Virginia.

The meeting was called to order by the Commissioner.

Moved by Mr. Wyzor, seconded by Mr. Massie, that the minutes of the meeting of November 12th, 1936, be approved.

Moved by Mr. Massie, seconded by Mr. Wyzor, that the Commission confirm the change in convict camps from Route 55, Approaching The Plains, and from Lowesville towards Route 60 on Route 151, to Route 55 from Chancellors Corner to Front Royal, Route 55. Motion carried.

At the request of the Governor the State Highway Commission conferred with the Governor and the Prison Control Board in the Governor's office on the question of convict labor. No conclusion was reached.
