

Minutes of the Meeting of the State Highway
Commission of Virginia, Held in
Richmond, March 14, 1934.

On the morning of March 14th, 1934, the State Highway Commission, consisting of Messrs. H. G. Shirley, Wade H. Massie, Secretary, H. G. Gilmer, Wm. H. East, and S. W. Rawls, met in their office, State Office Building, Richmond, Virginia.

The meeting was called to order by the Commissioner.

Moved by Mr. Gilmer, seconded by Mr. East, that the minutes of the meeting of January 3rd be approved. Motion carried.

Moved by Mr. Massie, seconded by Mr. Gilmer, that the Commission confirm award of contract for the construction of Project NRS 691 C2, Route 48, 2.66 Mi. W. Sussex C.H.-0.01 Mi. W. EOL Stony Creek, to the low bidder, Chandler Brothers, Inc., Virginia, Va., at their bid of \$40,940.44, and that 10% additional be set aside to cover the cost of engineering and additional work; \$710.66 for soil rights, and \$2,761.00 for surface treatment, making a total of approximately \$49,000.00 chargeable to this project. Motion carried.

Moved by Mr. Shirley, seconded by Mr. Rawls, that the Commission confirm award of contract for the construction of Project NRS 1028A, Route 238, West Virginia Line-4.3 Mi. E. West Virginia Line, to the low bidder, Gilbert Construction Co. Inc., Beckley, West Va., at their bid of \$46,763.06, and that 10% additional be set aside to cover the cost of engineering and additional work; \$3,110.80 for guard rail and \$7,114.06 for surface treatment, making a total of approximately \$62,000.00 chargeable to this project. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Gilmer, that the Commission confirm award of contract for the construction of Project NEM 1028, Route 11, Connelly Run Fill in the City of Radford, to the low bidder, Perkins-Barnes Construction Co. Inc., Blackstone, Va., at their bid of \$18,201.29, and that 10% additional be set aside to cover the cost of engineering and additional work, and \$187.70 for surface treatment, making a total of approximately \$18,000.00 chargeable to this project. Motion carried.

Moved by Mr. East, seconded by Mr. Rawls, that the Commission confirm award of contract for the construction of Project NEM 1055 AOD, Routes 58 and 150, in Town of Franklin, to the low bidder, W. H. Scott, Franklin, Va., at his bid of \$14,354.35, and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$16,000.00 chargeable to this project. Motion carried.

Moved by Mr. Gilmer, seconded by Mr. Shirley, that the Commission confirm award of contract for the construction of Project NEM 1044A, Route 15, Street in Gordonville, to the low bidder, Rhoades and Walters, Culpeper, Va., at their bid of \$12,168.60, and that 10% additional be set aside to cover the cost of engineering and additional work, and \$720.35 for surface treatment, making a total of approximately \$15,000.00 chargeable to this project. Motion carried.

Moved by Mr. Gilmer, seconded by Mr. Massie, that the Commission confirm award of contract for the construction of Project NEM 1051C, Route #60, Virginia Avenue in Grewe, to the low bidder, Perkins-Barnes Construction Co. Inc., Blackstone, Va., at their bid of \$4,996.15, and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$5,000.00 chargeable to this project; the work to be cut off to come within the \$5,000.00 allocation. Motion carried.

Moved by Mr. Shirley, seconded by Mr. Gilmer, that the Commission confirm rejection of all bids on Project 476A, Route 86, 3.93 Mi. W. WOL Gate City-WOL Gate City, and do the work by force account. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Shirley, that the Commission confirm award of contract for the construction of Project NRS 1072 A51, Route 16, Willis River Bridge and Approaches, to the low bidder, Hall and Mitchell, Keswick, Va., at their bid of \$24,051.85, and that 10% additional be set aside to cover the cost of engineering and additional work; \$122.05 for soil rights, and \$1,085.85 for surface treatment, making a total of approximately \$28,000.00 chargeable to this project. Program to be revised to take care of the difference in allocation and contract price. Motion carried.

Moved by Mr. East, seconded by Mr. Massie, that the Commission confirm award of contract for the construction of Project NRH 120 A51, 2, 51, 0.146 Mi. E. Smith Creek-0.82 Mi. W. Smith Creek and Bridge over Smith Creek, to the low bidder, Rhoades and Walters, Culpeper, Va., at their bid of \$15,710.04, and that 10% additional be set aside to cover the cost of engineering and additional work; \$205.60 for guard rail and \$382.04 for surface treatment, making a total of approximately \$19,000.00 chargeable to this project. Program to be revised to take care of difference in cost and allocation. Motion carried.

Moved by Mr. Gilmer, seconded by Mr. Rawls, that the Commission confirm award of contract for the construction of Project NEM 1080 G55, Route 11, in Town of Salem, to the low bidder, Draper and McCamell, Roanoke, Va., at their bid of \$12,901.05, and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$15,000.00 chargeable to this project. Motion carried.

Moved by Mr. Rawls, seconded by Mr. Massie, that the Commission confirm award of contract for the Repair of Fender System to Bridge over Appomattox River at Hopewell, Route 87, Project 8480 A1, to the low bidder, Tidewater Construction Corporation, Gloucester Point, Va., at their bid of \$1,890.50, and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$2,000.00 chargeable to this project. Motion carried.

Moved by Mr. East, seconded by Mr. Gilmer, that the Commission confirm award of contract for the construction of Project NEH 879C, Route 460, Campbell County Line-Forest, to the low bidder, Helle L. Teer, Durham, N.C., at his bid of \$72,517.05, and that 10% additional be set aside to cover the cost of engineering and additional work; \$2,125.00 for guard rail and \$7,709.14 for surface treatment, making a total of approximately \$80,000.00 chargeable to this project. Motion carried.

Moved by Mr. Gilmer, seconded by Mr. Massie, that the Commission confirm award of contract for the construction of Project NEH 1090, Route 644, Compostella Bridge, over Eastern Branch of Elizabeth River, to the low bidder, Virginia Engineering Company, Inc., Newport News, Va., and Tidewater Construction Corporation, Norfolk, Va., at their bid of \$373,176.03, and that 10% additional be set aside to cover the cost of engineering and additional work, making a total of approximately \$411,000.00 chargeable to this project. Motion carried.

Moved by Mr. Massie, seconded by Mr. Rawls, that the Commission confirm award of contract for the construction of Project NBS 761 A1, Route 340, 1.17 Mi. S. SCL Front Royal-2.4 Mi. S. SCL Front Royal, to the low bidder, Echols Brothers, Inc., Staunton, Va., at their bid of \$51,464.80, and that 10% additional be set aside to cover the cost of engineering and additional work; \$1,597.00 for guard rail and \$1,771.26 for surface treatment, making a total of approximately \$80,000.00 chargeable to this project. Motion carried.
