Caroline County

The purpose of this project is to alleviate congestion by relocating the existing Route 207/Route 652 intersection approximately 1000 feet to the east. This project is relocation of Route 652, 0.443 miles south of Carmel Church Road to 0.369 miles to the north. Intersection improvements will include turn lanes, a new signal, three retention ponds, installation of drainage structures and pipes, pavement and paved shoulders and installation of guardrail at selected places.

Salem District

The purpose of this project is to repave approximately 6.58 miles of I-81 in Botetourt and Pulaski Counties. Included in this work will be shoulder paving and the upgrading of all guardrail components. All work will be performed within existing right of ways and no utilities will be impacted.

City of Norfolk

This project on Hampton Boulevard is to remove the existing at grade conflict with the Norfolk Southern / Norfolk Portsmouth Beltline railroad. The project limits will begin at Maple Shade Ave. and terminate at "B" Avenue. This 0.8 kilometer improvement will provide 6-lanes for thru traffic and a 4.8 meter median for left turn lanes as needed. The proposed roadway will provide improved roadway lighting, signals, drainage, landscaping, bike lanes, curb and gutter and sidewalks. There will be two new bridges constructed. The first bridge will provide a railroad crossing; the second bridge will provide vehicle access into Norfolk International Terminal and the US Navy's Gate 6. The project will provide a 6-lane detour roadway with adequate median for turn lanes during construction. This detour roadway will provide access into both facilities while maintaining the same capacity as existing Hampton Boulevard. Other improvements will include access into US Navy Fleet Recreational Park, Pier 3 Access and improvements to the Maple Shade and Greenbrier side streets.

This is a milling paving, and guardrail upgrades project and will be in the south bound lane on I-81 from Mile Marker 19.63 to 25.36. Temporary lane closures will be used to minimize inconvenience to traveling public.

Prince Edward County

The project is 2.88 miles in length from 1.35 miles E of Route 735 to the Nottoway County Line. This project involves milling the existing 24' wide pavement and existing paved shoulder (approx. 2' each side) of Route 460 EBL. The travel way rehabilitation involves Milling, Grading, placing 5.0" of Base Mix BM-25.0A, placing 2.0" of Intermediate mix IM-19.0D and placing 2.0" of SM-12.5 D. The outside shoulder of Route 460 EBL will require the existing area to be excavated 6'-8' wide and be reconstructed using 6.0" of aggregate base 21B, 6.0" of base mix BM-25.0A and placing 2.0" of SM-12.5D. The inside shoulder of Route 460 EBL will require the existing area to be excavated 4' wide and be reconstructed using 6.0" of aggregate base 21B, 6.0" of base mix BM-25.0A and placing 2.0" of SM-12.5D. The roadway will be open to traffic at all times.

This is a milling paving, and guardrail upgrades project and will be in the north bound lane of I-77 from Mile Marker 24.19 to 25.69 and 26.59 to 29.22 and also on the south bound lane of I-77 from Mile Marker 46.31 to 40.69. Temporary lane closures will be used to minimize inconvenience to traveling public.

Spotsylvania and Stafford Counties

This project is located in the Fredericksburg District and is comprised of six individual locations. Three locations are located in Spotsylvania County and three locations are located in Stafford County, all sections are located along Route 95 (I-95). I-95 at these locations is comprised of three 12' wide lanes in each direction for a total pavement mainline width of 36'. The shoulders are also paved and are 10' wide along each side of the mainline. The planned work for this project will be performed from the early evening to early morning hours (nights) with the possibility of some shoulder work performed during the day. The planned work is a typical planning (removal) & replacement of the existing surface of the interstate mainline, as well as the associated interchange ramps and or loops. This work will consist of planning off 2.0" of the existing asphalt surface and replacing with 2.0" of hot mix asphalt. The planned work for the shoulders consist of planning off 2.0" of the existing asphalt surface and replacing with 2.0" of hot mix asphalt. These sections will also receive the installation of several safety enhancements, such as new pavement markings and markers, as well as the installation of milled rumble strips.

Fredericksburg District

This project is located in the Fredericksburg District, and will be administrated through the Northern Neck Residency. The project is comprised of eight individual sections; all sections currently have an asphalt surface and are designated as Primary System routes situated in a rural setting. Four sections are located in Lancaster County on Route 3, one section is located in Northumberland County on Route US 360, and three sections are located in Richmond County on Route 3, and US 360. These locations are typically a two lane 24' to 26' wide. Some sections are divided and some are undivided highway. All eight locations currently have limited asphalt and stone shoulders. The work for this project will be performed during the day. The planned work for the roadway will require some milling (removal of existing surface) and overlaid with hot mix asphalt concrete. The planned work for the shoulders consists of placing aggregate base material adjacent to and compacted level to the top of the new asphalt overlay. These sections will also receive the installation of new traffic safety features such as pavement markings, pavement messages, and raised pavement markers. Construction impacts are anticipated to be minimal with one lane of traffic maintained at all times during construction.
