Transportation Demand Management (TDM) Definition

- ❑ Providing travelers with effective choices to improve travel reliability - FHWA
- ❑ The application of programs, projects and policies to reduce travel demand or to redistribute this demand.
 - Mode of travel
 - Time of travel
 - Route
 - Eliminate trip

Benefits of TDM

- ❑ Optimizes transportation system
- ❑ Improves mobility
- ❑ Reduces traffic congestion
- ❑ Improves air quality
- ❑ Scalable – regions, local jurisdictions, communities, individuals

How It's Done

- Move more people in fewer vehicles
- Remove auto trips
- Redistribute auto trips
- Get riders on transit

- Employer Outreach

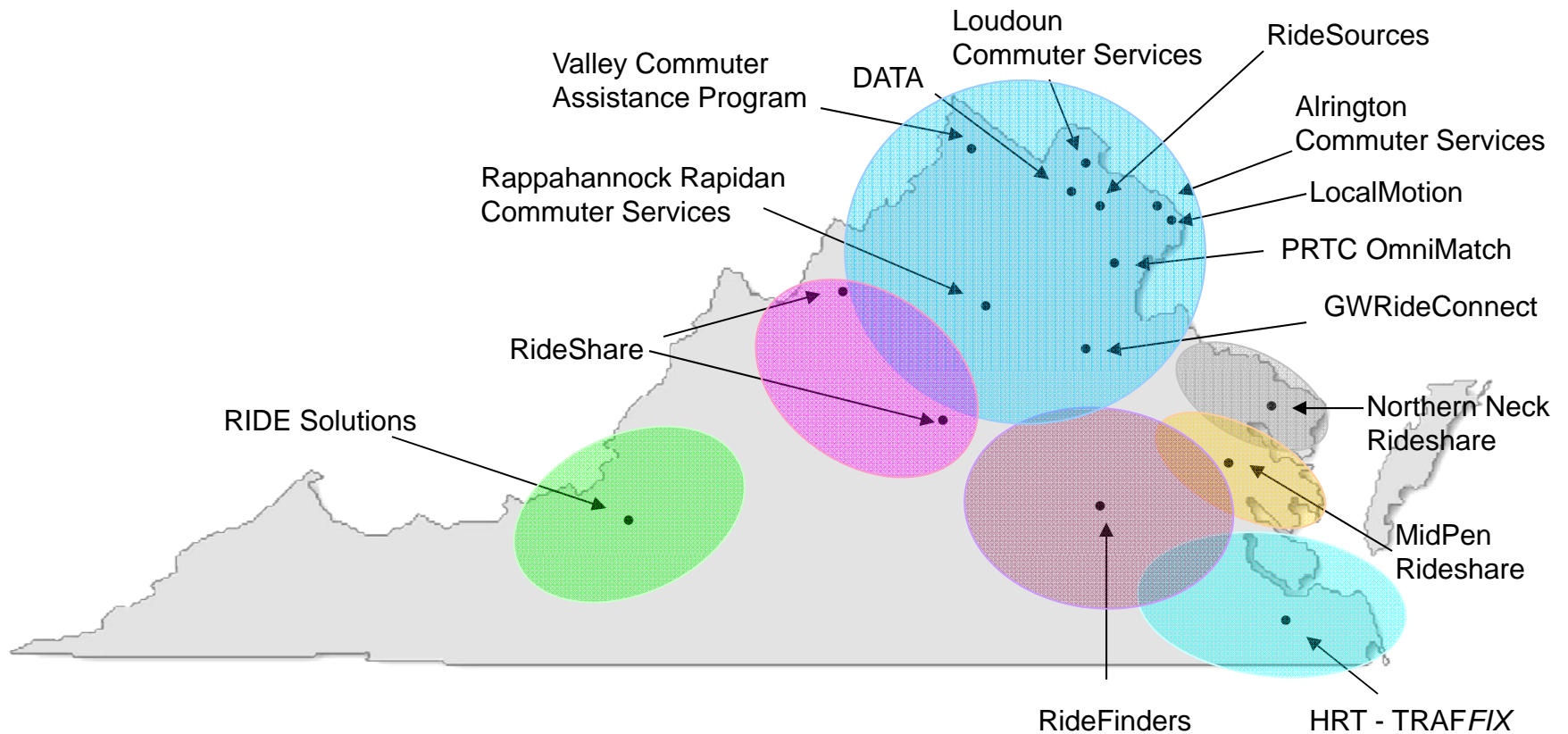
Why Market and Promote?

- Inform/educate
- Leads to acceptance
- Leads to trial and usage
- Leads to advocacy

What DRPT is Doing

- ❑ Funding/technical assistance/promotion for 16 TDM agencies
- ❑ Evaluation
 - Statewide State of the Commute
 - Placement Rate Study
 - Program performance measures
- ❑ Long-range TDM planning
- ❑ Consolidate ridematching systems for central, southeast and southwest TDM programs
- ❑ Partner with VDOT on Megaprojects

Telework Tax Credit

- ❑ Up to \$50,000 per business for taxable years 2012 and 2013
 - Up to \$20,000 for a telework assessment
 - Up to \$1,200 per employee for eligible expenses
 - Computer equipment (laptops/netbooks/tablets)
 - Networking equipment and software
 - Security and antivirus systems
 - High speed Internet access
 - Communications equipment and services (VoIP, mobile phones, Smartphones, routers, modems/web cams, VPN)
 - Telework Center fees
- ❑ Total statewide credits not to exceed \$1 million annually

Telework!VA

- ❑ 174 business participants
- ❑ \$35,000 financial incentive (funding has been exhausted)
- ❑ Use Tax Credit as financial incentives
- ❑ Use unspent funds for non-profits
- ❑ Technical assistance provided by consultants hired by businesses
- ❑ Telework!VA website – resources, examples, training modules

Goals

- ❑ Reduce vehicle miles traveled (VMT)
 - DRPT Virginia Performs Measure
 - 2% annual growth goal
 - By TDM agencies (~13 million miles in FY2011)

- ❑ Increase teleworking – private sector
 - Potential 751,000 new teleworkers statewide*

- ❑ 20% of eligible state workforce
 - Section 2.2-2817.1 of Code of Virginia
 - to Secretaries of Administration and Technology
