# **January 2017 CTB Meeting**

**Shenandoah County**

Route 11 is an important link for traffic in the Strausburg/Middletown area for motorists traveling from Route 81 South of Strausburg to Middletown, as well as incident management for I-81. The proposed construction of this roadway maintains this connectivity by replacing two structurally deficient bridges.

The project on Valley Pike covers the area from 0.4 miles south of Cedar Creek to 0.3 miles north of Cedar Creek. Currently this portion of Rte. 11 is fronted by open land, limited individual housing, an RV Park and is the entry way into the Shenandoah Valley National Battlefield. All new construction for this project is within the existing right of way. The existing Average Daily Traffic (ADT) count is 4000 VPD. The existing roadway consists of a four lane divided section of roadway with 2-12 foot lanes with variable width shoulders in each direction.

The primary purpose of this project is to replace the southbound and northbound bridges over Cedar Creek. The SB bridge was built in 1947 and the NB bridge was built in 1959. The four lane divided roadway drops to three lanes on the north side of the project area. This project replaces the two bridges with a single two-lane two-way bridge on the same location as the existing NB bridge.

Two properties will be impacted by the construction but will not require relocation. During construction, south and northbound traffic will be maintained at all times on the existing roadways.
