RESOLUTION OF THE COMMONWEALTH TRANSPORTATION BOARD

June 20, 2018

MOTION

Title: FY 2019 and FY 2020 Revenue Sharing Program

WHEREAS, § 33.2-357 of the *Code of Virginia* prescribes the allocation of state funds by the Commonwealth Transportation Board (Board), from revenues made available by the General Assembly each year, to provide an equivalent matching allocation for certain local funds designated by the governing body for projects addressing improvement, construction, reconstruction, or maintenance of systems of highways; and

WHEREAS, § 33.2-357 further stipulates that, “[i]n allocating funds under this section, the Board shall give priority to projects as follows: first, to projects that have previously received an allocation of funds pursuant to this section; second, to projects that (i) meet a transportation need identified in the Statewide Transportation Plan pursuant to § 33.2-353 or (ii) accelerate a project in a locality’s capital plan; and third, to projects that address pavement resurfacing and bridge rehabilitation projects where the maintenance needs analysis determines that the infrastructure does not meet the Department’s maintenance performance targets”; and

WHEREAS, the governing bodies of certain eligible localities electing to participate in this program for FY 2019 and FY 2020 have, in concert with the Virginia Department of Transportation (VDOT), identified specific eligible items of work; and

WHEREAS, project requests for the FY 2019 and FY 2020 program determined to be eligible and in conformance with this Board’s Revenue Sharing Program Guidelines (Guidelines) total \$246,753,177 and exceed available funding; and

WHEREAS, the Board has selected projects, set out in Attachment A, for the FY 2019 and FY 2020 Revenue Sharing Program allocations in accordance with the priority criteria established in § 33.2-357 of the *Code of Virginia*; and

WHEREAS, the Board has also selected projects, set out in Attachment A, in accordance with the priority criteria established in §33.2-357 of the *Code of Virginia*, for the redistribution of prior years' allocations, deallocated as of the current date by the CTB in accordance with the Guidelines; and

WHEREAS, the Board established the Guidelines as supplementary procedures in distributing and administering Revenue Sharing Program funds; and

WHEREAS, pursuant to the Guidelines, if available funding is depleted prior to completely funding all projects within a priority, any remaining funds will be pro-rated within that priority or allocated as otherwise directed by the Board; and

WHEREAS, based on available funding which includes FY 2019 and FY 2020 allocations and prior years' allocations previously deallocated and available for redistribution, all project requests that have previously received an allocation of revenue sharing funds pursuant to § 33.2-357 will be fully funded; and

WHEREAS, pursuant to the Guidelines and based on available funding, localities with total requests, up to \$1 million, that meet a transportation need in the Statewide Transportation Plan or accelerate a project in a locality's capital plan will be funded; and

WHEREAS, pursuant to the Guidelines and based on available funding localities with total requests, exceeding \$1 million, that meet a transportation need in the Statewide Transportation Plan or accelerate a project in a locality's capital plan will receive a pro-rated amount of the remaining available funding; and

WHEREAS, pursuant to the Guidelines and based on available funding, localities with requests for pavement resurfacing and bridge rehabilitation projects where the maintenance needs analysis determines that the infrastructure is below the Department's maintenance performance targets and with requests for all other eligible items that do not fall in other priorities will not receive funding; and

WHEREAS, it appears that the items of work set out in Attachment A fall within the intent of funding set forth in § 33.2-357 and comply with the Guidelines of the Board for use of such funds.

NOW, THEREFORE, BE IT RESOLVED, that the Commonwealth Transportation Board hereby approves the project allocations as set forth in "Attachment A" for funding pursuant to § 33.2-357 of the *Code of Virginia*, totaling \$200,000,000 from funding available for allocation in FY19 and FY 20 and totaling \$17,161,200 from funding available for redistribution from prior years' allocations.

CTB Decision Brief

FY 2019 and FY 2020 Revenue Sharing Program Allocations

Issue: Pursuant to § 33.2-357 of the *Code of Virginia (Code)*, the Commonwealth Transportation Board (CTB) may make an equivalent matching allocation from revenues made available by the General Assembly (“Revenue Sharing allocation”) for improvement, construction, reconstruction, or maintenance of systems of state highways to any locality for designations by the governing body under certain conditions. VDOT has received requests for Revenue Sharing Program allocations from several localities pursuant to this section of the *Code*. Localities cannot proceed with requested projects until the CTB has approved the allocations. Approval of Revenue Sharing Program allocations for specified projects meeting statutory requirements and CTB Revenue Sharing Program Policy and Guidelines (collectively, the Revenue Sharing Program) is sought.

Facts: According to the *Code*, effective July 1, 2018, CTB annual allocations “shall not exceed the greater of \$100 million or seven percent of funds available pursuant to subsection D of 33.2-358 ...” for the Revenue Sharing Program. The CTB Revenue Sharing Program Policy allows eligible localities to request up to \$5 million annually (\$10 million biennially) to improve, construct, reconstruct or maintain the highway systems located within such locality, in another locality or between two or more localities with up to \$2.5 million annually (\$5 million biennially) for use by a locality for maintenance of the highway systems within the locality (ies). Allocations for the Revenue Sharing program are made on a biennial cycle and the current cycle is for fiscal years 2019 and 2020.

In allocating funds under 33.2-357, priority must first be given to projects that have previously received revenue sharing allocations; second, to projects that (i) meet a transportation need identified in the Statewide Transportation Plan or (ii) accelerate a project in the locality’s capital plan; and, third, to those pavement resurfacing and bridge rehabilitation projects where the maintenance needs analysis determines that the infrastructure is below VDOT’s maintenance performance targets. The CTB’s procedures for administering this Program and the distribution of the Revenue Sharing Program funds for fiscal year 2019 and fiscal year 2020 are dictated by its policy and the Revenue Sharing Program Guidelines (Guidelines), adopted July 19, 2017.

87 localities initially provided applications for the current funding cycle. These localities submitted requests for \$254,627,864 in state matching funds. Following review of requests with appropriate application and accompanying documentation, and updates of project estimates, this figure was revised to 86 localities with a total request of \$246,753,177. All localities that submitted applications for multiple projects prioritized their projects, as required by the *Code*. VDOT reviewed the applications and found that:

- \$69,571,919 in funding requests were for projects that have previously received revenue sharing allocations;
- \$155,895,696 in funding requests were for projects that would meet a transportation need in the Statewide Transportation Plan or would accelerate a project in the locality’s capital plan;

- \$7,913,605 in funding requests were for projects that would address pavement resurfacing and bridge rehabilitation maintenance needs;
- \$13,371,957 in funding requests were for projects that were eligible but did not meet the funding priority selection criteria per the *Code*.

Total funding available for applications submitted this cycle is \$217,161,200, and consists of (i) Revenue Sharing funds budgeted for fiscal year 2019 and fiscal year 2020, totaling \$100,000,000 for each fiscal year and (ii) prior years' allocations previously de-allocated by the CTB and now available for redistribution, totaling \$17,161,200.

- All funding requests for projects that have previously received Revenue Sharing Program allocations are recommended to receive the full amount requested (\$69,571,919).
- Funding requests for projects that meet a transportation need in the Statewide Transportation Plan or would accelerate a project in the locality's capital plan are being recommended funding up to \$1 million per locality and requests over \$1 million are recommended to be pro-rated at 91.8%, in accordance with the Guidelines.
- The prior two funding priorities will utilize all funds available for FY 2019 and FY2020 leaving no funding available for projects intended to address pavement resurfacing or bridge rehabilitation maintenance needs, or otherwise eligible projects that do not meet a funding priority selection criteria per the *Code*.
- The projects that are recommended to receive funding in FY 2019 and FY 2020 are included in the list entitled "Attachment A".

Recommendation: VDOT recommends that the allocations indicated under the respective columns "FY19 State Match Allocations", "FY20 State Match Allocations" and "Redistribution of Prior Allocations" be made for these projects identified on "Attachment A."

Action Required by CTB: *The Code of Virginia* requires the CTB to make the allocations for revenue sharing funds. A resolution is provided for formal vote.

Result, if Approved: The localities will be able to use the allocated funds for projects in accordance with their governing bodies' requests to the CTB. VDOT and the localities will be able to proceed with the projects once they are notified funds are available.

Options: Approve, Deny, or Defer.
