**Title: Commending F. Gary Garczynski**

**WHEREAS**, F. Gary Garczynski served on the Commonwealth Transportation Board (Board) from 2010 to 2018, having been appointed to serve on the Board by Governor Robert F. McDonnell, and subsequently reappointed by Governor Terry McAuliffe, and serving as an At-Large Urban member from 2010 to 2012, as a member representing the Northern Virginia Construction District from 2012 to 2016, and again as an At-Large Urban member from 2016 to 2018; and

**WHEREAS**, Mr. Garczynski brought to his tenure on the Board a documented and diverse record of achievement and leadership in the private sector, both in the housing and banking industry; and

**WHEREAS**, Mr. Garczynski, in his public sector experience, has diligently served the Commonwealth, not only in his service on the Commonwealth Transportation Board but also in other key roles, including an appointment to the Virginia Housing Commission from 2005 to 2010 and as a member of the Northern Virginia Transportation Authority, representing the Commonwealth Transportation Board; and

**WHEREAS**, Mr. Garczynski's service in the public sector has also extended to the local level and includes his service as a member of the Prince William County Economic Development Task Force from 2009-2010 and service on the board of directors for the Hylton Performing Arts Center; and

**WHEREAS**, Mr. Garczynski's dedication to transportation in the Commonwealth has been reflected not only in his service on this Board but also in his prior role as President of

the Northern Virginia Transportation Alliance and his service on the board of directors for the Washington Airports Task Force; and

**WHEREAS**, Mr. Garczynski, in fulfilling his duties with this Board, both as a member and Vice Chairman, has demonstrated leadership, dedication, forthrightness and commitment, earning the respect and admiration of his colleagues and the staff at the Virginia Department of Transportation and the Department of Rail and Public Transportation; and
