# RESOLUTION OF THE COMMONWEALTH TRANSPORTATION BOARD

February 21, 2023

#### **MOTION**

**Action:** Motion Carried, Unanimously

Title: Bridge Naming: "Dominic 'Nick' J. Winum Memorial Bridge"

WHEREAS, in accordance with § 33.2-213 of the *Code of Virginia*, the Page County Board of Supervisors has requested, by resolution dated November 7, 2022, that the Commonwealth Transportation Board (CTB), to honor and memorialize the life, service and ultimate sacrifice of Dominic "Nick" J. Winum, name the bridge on U.S. Route 211 West, over the South Fork of the Shenandoah River, Page County, as the "Dominic 'Nick' J. Winum Memorial Bridge"; and

**WHEREAS,** Page County, by resolution dated November 7, 2022, has agreed to be responsible for payment of all sign costs billed by the Virginia Department of Transportation calling attention to this naming, which will include the costs to produce, place, and maintain the signs; and

WHEREAS, § 33.2-213 provides that the Virginia Department of Transportation (VDOT) shall place and maintain appropriate signs indicating the names of highways, bridges, interchanges, and other transportation facilities named by the CTB and requires that the costs of producing, placing, and maintaining such signs shall be paid by the localities in which they are located or by the private entity whose name is attached to the transportation facility so named.

**NOW THEREFORE BE IT RESOLVED,** pursuant to § 33.2-213 of the *Code of Virginia*, the CTB hereby names the bridge on U.S. Route 211 West, over the South Fork of the Shenandoah River, Page County, as the "Dominic 'Nick' J. Winum Memorial Bridge".

**BE IT FURTHER RESOLVED,** that VDOT is directed to produce, place, and maintain the signs calling attention to this naming, and secure payment from Page County for these costs as required by law.

#### **CTB Decision Brief**

Bridge Naming: "Dominic 'Nick' J. Winum Memorial Bridge"

**Issue:** Commemorative naming of the bridge on U.S. Route 211 West, over the South Fork of the Shenandoah River, Page County, as the "Dominic 'Nick' J. Winum Memorial Bridge".

**Facts:** The Page County Board of Supervisors enacted a resolution on November 7, 2022 to honor Dominic J. "Nick" Winum's life and ultimate sacrifice to his community.

According to that resolution, Mr. Winum began his career in law enforcement as a State Trooper with the Virginia State Police from 2006-2016 and then served as an Officer with the Stanley Police Department from 2016-2021.

Dominic "Nick" J. Winum was a dedicated servant who selflessly sacrificed his own life in the line of duty on February 26, 2021 while serving and protecting his community.

One of his favorite spots while patrolling U.S. Route 211 West was in the area of the White House Bridge where he could enjoy the scenic view of the Shenandoah River. The White House Bridge was recently replaced, upgrading the structure over the South Fork of the Shenandoah River.

**Recommendations**: The Virginia Department of Transportation (VDOT) recommends this request be approved.

**Action Required by CTB**: The *Code of Virginia* requires a majority of the CTB members to approve a resolution naming a highway or bridge, as appropriate. A resolution will be provided For the Board's consideration.

**Result if Approved**: The bridge on U.S. Route 211 West, over the South Fork of the Shenandoah River, Page County, will be known as the "Dominic 'Nick' J. Winum Memorial Bridge". In accordance with law, and by resolution dated November 7, 2022, Page County agrees to pay the costs of producing, placing, and maintaining the signs calling attention to this naming.

**Options:** Approve, Deny, or Defer.

**Public Comments/Reactions:** VDOT is not aware of any opposition to this proposal.

WHEREAS, this Board wishes to honor and memorialize the life and sacrifice of Dominic "Nick" J. Winum.


