Title: Location Approval I-264 Ramps/London Bridge Road City of Virginia Beach

WHEREAS, in accordance with the statutes of the Commonwealth of Virginia and policies of the Commonwealth Transportation Board, a Public Hearing was held on Thursday, May 15, 2008 at the Plaza Middle School in the City of Virginia Beach, between 4:00 pm and 7:00 pm for the purpose of considering the proposed location for these new access ramps from I-264 to London Bridge Road, in the City of Virginia Beach, State Project 0264-134-103, PE101, RW201, C501, B610, B611, Federal Project HHP-264-6 (099); and

WHEREAS, proper notice was given in advance, and all those present were given a full opportunity to express their opinions and recommendations for or against the proposed project as presented, and their statements being duly recorded; and

WHEREAS, the economic, social, and environmental effects of the proposed project have been examined and given proper consideration, and this evidence, along with all other, has been carefully reviewed; and

NOW, THEREFORE, BE IT RESOLVED, that the location of the interchange ramps at I-264/London Bridge Road is approved, as proposed and presented at the public hearing.

BE IT FURTHER RESOLVED, that in the interest of public safety, pedestrians, persons riding bicycles, electric power-assisted bicycles, motorized skateboards or scooters, electric personal assistive mobility devices or mopeds, Animal-drawn vehicles, self-propelled machinery or equipment, and animals led, ridden or driven on the hoof be prohibited from using Ramp A I-264 eastbound to London Bridge Road from station 36+24.30 to 49+44.73 and Ramp B London Bridge Road to westbound I-264 from station 49+53.15 to 37+89.64.

BE IT FURTHER RESOLVED, that I-264 Ramp A/London Bridge Road is designated as a limited access highway between station 36+24.30 to 49+44.73 and Ramp B London Bridge Road to westbound I-264 from station 49+53.15 to 37+89.64 as proposed and presented at the public hearing in accordance with the statues of Virginia and in accordance with the Commonwealth Transportation Board policies.
