TITLE: Supplemental Allocation:

Rail Enhancement Fund Program

WHEREAS, Section 33.1-221.1:1.1 of the *Code of Virginia*, declares it to be in the public interest that the retention, maintenance, improvement and development of the railways are essential to the Commonwealth's continued economic growth, vitality, and competitiveness in national and world markets, and creates the Rail Enhancement Fund; and

WHEREAS, pursuant to Chapter 879, Item 450 of the 2008 *Acts of Assembly*, funding is provided by the General Assembly for Rail Enhancement Fund projects; and

WHEREAS, in accordance to Section 33.1-221.1:1.1 of the *Code of Virginia*, the Director of DRPT, prior to recommending Rail Enhancement Fund projects to the Commonwealth Transportation Board (the Board), consulted with and obtained the advice and recommendations of the Rail Advisory Board on May 16, 2008; and

WHEREAS, on May 16, 2008, by majority vote the Rail Advisory Board recommended for approval the Rail Enhancement Fund projects proposed by the Director of DRPT; and,

WHEREAS, the proposed Rail Enhancement Fund projects were included in the Draft FY2009-FY2014 Six-Year Improvement Program that was distributed for public comment in spring 2008; and

WHEREAS, the Board, on June 19, 2008, adopted the FY2009 –FY2014 Six-Year Improvement Program, which includes \$57,704,481 in Rail Enhancement funds for FY2009; and

WHEREAS, DRPT is hereby advancing recommended projects, as attached hereto, to the Board for approval; and

WHEREAS, the Board has determined that these projects will result in public benefits to the Commonwealth or to a region of the Commonwealth that are equal to or greater than the investment of Rail Enhancement funds as required by Section 33.1-221.1:1.1 of the *Code of Virginia*.

NOW, THEREFORE, BE IT RESOLVED that the Board hereby approves the allocation of \$26,604,547 to be applied to the attached listing of Rail Enhancement Fund projects as set forth for FY2009 and the Board hereby amends the FY2009-FY2014 Six-Year Improvement Program to include said projects contingent upon:

1. The provision of local matching funds at the level agreed to by the applicant, which shall be a minimum of thirty percent (30%) cash or in-kind contribution.
2. Execution of an agreement acceptable to the Director of the Department of Rail and Public Transportation.
