### **RESOLUTION OF THE COMMONWEALTH TRANSPORTATION BOARD**

**September 20, 2007**

#### **MOTION**

#### **Title: Land Conveyance, Routes 49 and old 742, Mecklenburg County**

**WHEREAS**, in connection with Route 49, State Highway Project 3458-06, the Commonwealth acquired certain land from N. H. Orr, et al., by Deed dated March 14, 1956, recorded in Deed Book 157, Page 336; and Garland C. Pennell, et al., by Deed dated March 19, 1956, recorded in Deed Book 157, Page 480, both recorded in the Office of the Clerk of the Circuit Court of Mecklenburg County; and

**WHEREAS**, a section of old Route 742 is no longer necessary as a public road since the new location of Route 49 serves the same citizens as the old location; and

**WHEREAS**, in accordance with Section 35-76.12, predecessor to Section 33.1-155 of the *Code of Virginia* (1950), as amended, the Mecklenburg County Board of Supervisors, at its meeting held August 3, 1957, abandoned a section of old Route 742; and

**WHEREAS**, the Commonwealth Transportation Commissioner has certified in writing that the land containing 0.569 acre, more or less, as shown on the plans for State Highway Project 3458-06, and lying west of and adjacent to the west revised proposed right of way line of Route 49 from a point approximately 40 feet opposite approximate Station 560+65 (Route 49 centerline) to a point approximately 40 feet opposite approximate Station 564+20 (Route 49 centerline) does not constitute a section of the public road and is deemed by him no longer necessary for the uses of the State Highway System; and

**WHEREAS**, this conveyance is to be made in accordance and compliance with the provisions and notice requirements of Sections 33.1-149, 33.1-154 and 33.1-223.2:2 of the *Code of Virginia* (1950), as amended; and

**WHEREAS**, the adjacent landowner has requested that the surplus land be conveyed.

**NOW, THEREFORE, BE IT RESOLVED**, in accordance and compliance with the provisions and notice requirements of Sections 33.1-149, 33.14-154 and 33.1-223.2:2 of the *Code of Virginia* (1950), as amended, the conveyance of the said land, so certified, is approved and the Commonwealth Transportation Commissioner is hereby authorized to execute, in the name of the Commonwealth, a deed conveying the land for a consideration satisfactory to the State Director, Right of Way and Utilities, subject to such restrictions as may be deemed appropriate.
