**WHEREAS**, the Commonwealth Transportation Board (CTB) is committed to supporting efficient and effective transit service throughout Virginia; and

**WHEREAS**, the Greater Richmond Transit Company provides fixed route transit service throughout the City of Richmond, Henrico County and parts of Chesterfield County, two Extended Express routes with service to the City of Petersburg and the City of Fredericksburg, and specialized services such as CARE, C-VAN and RideFinders; and

**WHEREAS**, the Greater Richmond Transit Company provided 15,198,857 passenger trips in fiscal year 2007; and

**WHEREAS**, the Greater Richmond Transit Company has demonstrated significant achievements in efficiency and effectiveness over three consecutive years in business areas such as safety, operations, customer service, financial management, human resources, minority and women advancement, marketing, policy and administration, and community relations; and
